

- 1) Consumer Shri. Rajesh Gopalrao Telkar purchased shop No.09 at S.No. 39/2/2 Yugay Mangal, Archana nagar, Erandavana Pune-04 on 18th Sept. 2010 having existing electricity connection bearing Consumer no. 160260443272. The said shop was closed till March -2011. The electricity connection was disconnected on 11/02/2011, which was in the name of Anil Krishnalal Marda. The consumer applied for reconnection of supply, which was accordingly done on part payment of Rs.10,000/- (Ten thousand only) and Rs.100/- (One hundred) towards reconnection charges as per directions of Officers of Maharashtra State Electricity Distribution Co. Ltd, (MSEDCL) under protest.
- 2) Consumer requested for change of name for which he paid Rs. 3500/- (Rs. three thousand and five hundred) as per the quotation issued by


MSEDCL dt.27/02/2011. However, no cognizance was taken and consumer was asked to pay old arrears of an amount of Rs.49,660/-


- 3) The grievance of the consumer was made to Internal Grievance Redressal Cell on 18/04/2012 in respect of which hearing was held on 02/05/2012 however no relief was granted by Internal Grievance Redressal Cell (IGRC).
- 4) The main prayer of consumer before this forum is to direct MSEDCL to correct the bill as per MERC (Electricity Supply Code & other conditions of Supply) Regulation-2005 Sect. 10.5 and change the name of consumer. The MSEDCL agreed to charge bills as per Regulation 10.5 on the date of hearing.
- 5) We have heard both sides. We persuaded both sides to settle the issues by amicable settlement in conformity with the rules & regulations framed as per Electricity Act-2003 and MERC (Electricity Supply Code & other conditions of Supply) Regulation-2005
- 6) Both sides filed compromise pursis on record. In view of the compromise, consumer has submitted that, he be permitted to withdraw the case. We accord permission to withdraw the complaint.

ORDER

Complaint is disposed of with no order as to cost.
