However, today i.e. on 26.02.2015 the said consumer submitted application contending that his grievance in respect of Consumer No.176010095604 about exorbitant billing has been settled at the level of Addl. Ex. Engineer, Chakan Sub/Dn. Therefore he does not want to proceed with the matter & therefore the said grievance be disposed off. Respondent has no objection for disposal of the grievance. Hence we pass the following order.

- 1. Grievance application stands disposed off since amicably settled between the parties vide application dated 26.02.2015.
