- 1) The Consumer has filed present Grievance application under regulation no. 6.4 of the MERC (CGRF & E.O.) Regulations 2006.
- 2) Being aggrieved and dissatisfied by the order dated 17.09.2014 passed by IGRC Pune Rural Circle, Pune, the consumer above named prefers this grievance application to the Forum.

- 3) The papers containing the above grievance were sent by the Forum to the Executive Engineer, M.S.E.D.C.L., Manchar Division, Pune vide letter no. EE/CGRF/PZ/Notice/37 of 2014/242 dtd.11.12.2014. Accordingly the Distribution Licensee i.e. MSEDCL filed its reply on 12.01.2015.
- 4) Energy connection bearing no.173060112136 for agriculture is standing in the name of Tatyaba Nana Kale. Present applicant namely Kantaram Tatyaba Kale is son of late Tatyaba Nana Kale. Sanctioned load is 5 HP. The connected load printed on bill is 7.5 HP instead of 5 HP. Consumer does not receive bills regularly he has paid bills of March-2014 & June-2014. However since he did not get regular bill he is likely to lose benefit of the scheme, hail stone, therefore consumer seeks remedy of getting compensation being loser of the said scheme.
- 5) On the other hand MSEDCL was representative Mr. Rasal Sidharth, Ex.Engineer, Manchar Division, Mr.Anil G.Chougule, Dy.Ex.Engr. Ghodegaon S/dn. They submitted that the said connection is Agriculture in the name of Tatyaba Nana Kale. New meter was installed in Dec.-2013. Regular & proper bills have been issued to the consumer. The consumer has paid all the bills. Consumer sanctioned load is 5 HP for Agriculture. However the consumer has not installed capacitor bank at consumer premises & Jr.Engineer, Ghodegaon checked the current of connected motor & found 12 Amp. Then SDO of Ghodegaon has installed the line capacitor & checked the load & subsequently revised the load of 7.5 HO to 5 HP. The consumer has availed the benefits of the scheme, " Krushi Sanjivani -2014" in the month of Dec.2014.
- 6) It is seen that the said connection in the name of Tatyaba Nana Kale. Present applicant i.e. Kantaram Tatyaba Kale is son of late Tatyaba Nana Kale. Consumer has paid the regular bills however he has not apply for change of name. Consumer has availed benefit of " Krushi

Sanjivani -2014" Scheme. Consumer load is revised 7.5 HP to 5 HP after installation of line capacitor & cross verified load by MSEDCL. However the applicant has not applied the change of name application, he could not set the hailstone benefit from Tahasildar, Ghodegaon. Therefore there is no substance in the grievance. Grievance is liable to be rejected.

- 7) Post of Chairperson, CGRF of this Zone was vacant during the period from 28.7.2014 to 7.12.2014 & CGRF member post was vacant from 1<sup>st</sup> Nov.2014 to 1<sup>st</sup> Feb.2015. Hence grievance could not be decided during a period of 2 months.

Hence the order

**ORDER**

1. Grievance application stands rejected with no order as to costs.
2. Licensee to report compliance within one month of receipt of this order.
