

## SELECT LIST FOR THE POSTS OF SUPERINTENDING ENGINEER (DIST.) ADVERTISED VIDE ADVT.NO. 03/2019.

- 1. Advertisement for the posts of Superintending Engineer (Dist.) was published during the month of June, 2019.
- 2. The selection process was held on 14<sup>th</sup> July, 2019 at Mumbai. Taking into consideration the performance in in-basket exercise, the candidates were shortlisted for personal interview.
- Taking into consideration performance of candidates in in-basket exercise, other tests and interview, the Select List for the post of Superintending Engineer (Dist) is prepared considering the terms and conditions mentioned in the advertisement.
- 4. The Select List will not confer any right on the candidate for appointment.
- 5. The selection of the candidates is purely on provisional basis subject to confirmation of the pre-requisites and other conditions as notified in the advertisement.
- 6. The candidate should ensure that he / she fulfills the eligibility criteria regarding educational qualification, experience, age, caste etc., and particulars furnished in the application form are correct in all respect. If any false /incorrect information furnished by the candidate is detected at any stage of recruitment process, then his/her candidature will not be considered.
- 7. Please note that it shall be sole responsibility of the candidate to prove his eligibility with respect to the experience in the relative responsible post/position. In case the applicant fails to do so, then his / her candidature will be liable to be cancelled at any stage of recruitment / appointment process.
- 8. The Company will take up verification of eligibility of the candidates with reference to original documents prior to issuance of the appointment letter. The decision of the Company in all matters of recruitment / interpretation shall be final and no individual correspondence will be entertained.
- 9. The candidates who are already employees of the Company, their selection is provisional subject to verification of educational qualification, experience, disciplinary action and F.I.R./vigilance investigation pending etc., if any and other service record.
- 10. The Government of Maharashtra introduced 16 % social reservation for Socially and Educationally Backward Class (SEBC) vide GR No. BCC.2018/P.K.581 A/2018/16-B dated 05/12/2018 and corrigendum No. BCC.2018/P.K.581 A/2018/16-B dated 19/12/2018. The provisions of social reservation for SEBC has been adopted by the Company vide C.S. No. 78 dated 21/01/2019 to the Classification and Recruitment Regulation, 2005.
- 11. Advertisement was published as per 16 % social reservation to the SEBC category. However, meanwhile the Government of Maharashtra revised the reservation policy of SEBC vide GR dated 04/07/2019. The GoM vide their letter dated 04/07/2019 instructed to fill up the vacancy of SEBC category of 13 % instead of 16%. Though roster points for 100 points roster for reservation is promulgated for 13% reservation for SEBC category, the small cadre roster for less than 32 sanctioned posts at 13% SEBC reservation is yet to be promulgated by the GoM.

Currently the matter is placed before Hon'ble Supreme Court of India and the final outcome as well as subsequent GoM directives in the matter are awaited.

- 12. Selection of all the SEBC category candidates is therefore provisional subject to outcome of the Hon'ble Supreme Court of India and any instructions by the GoM accordingly are received.
- 13. While every care has been taken in preparing the results, MSEDCL reserves the right to rectify any inadvertent or typographical error.
- 14. MSEDCL regrets inability to entertain any correspondence from unsuccessful candidates.
