

SELECT LIST FOR THE POST OF GRADUATE ENGINEER TRAINEE (CIVIL) & DIPLOMA ENGINEER TRAINEE (CIVIL/DIST.) VIDE ADVT. NO.06/2019 AND INTERNAL NOTIFICATION NO.01/2019.

- An advertisement No. 06/2019 was published for the post of Graduate Engineer Trainee (Civil) & Diploma Engineer Trainee (Civil/Dist.) and Internal Notification No.01/2019 was published in the month of August, 2019.
- 2. Due to certain changes, some change was made in the vacancy/backlog position for the post of Diploma Engineer-Trainee-(Dist.). Accordingly, corrigendum to the advertisement No. 06/2019 and internal notification No.01/2019 was uploaded on website of the Company on 21/08/2019. Accordingly, URL link for submission of online application was made available from 20/08/2019 to 03/09/2019.
- 3. The online test was conducted on 13th and 14th November, 2019 and candidates were allowed to appear for the online test based on the information submitted by the candidate in their online application.
- 4. Taking into consideration the performance in the online test and academic performance, the select list has been prepared.
- 5. The select list will not confer any right on the candidates for appointment.
- 6. The selection of the candidates is purely on provisional basis subject to confirmation of the pre-requisites and other conditions as notified in the advertisement.
- 7. In case of departmental employees of the Company, the selection is provisional, subject to verification of disciplinary action and vigilance investigation if any.
- 8. If it is subsequently found that, any selected candidate is not fulfilling the requirement of pre-requisites or not fulfilling any of the condition, his candidature is liable to be cancelled.
- 9. The selected candidates will have to serve anywhere in the territorial jurisdiction of the Company.
- 10. Maharashtra State Public Services (Reservation for Schedule Castes, Schedule Tribes, Denotified Tribes (Vimukta Jatis), Nomadic Tribes, Special Backward Class and Other Backward Classes) Act, 2001 has been enforced by the Govt. of Maharashtra from 29th January 2004. As per the provisions under Sub-section 2(ii) of Section-4 of this Act, the principle of Creamy-Layer has been made applicable to all categories except Schedule Castes and Scheduled Tribes i.e. VJ (A), NT (B), NT(C), NT(D), SBC, OBC & SEBC Category. The candidates should produce current years Non-Creamy Layer Certificate in the prescribed form issued by appropriate authority as per Govt. of Maharashtra Circular No. CBC-10/2006/PK15/BCR-5 dt. 05/06/2006.

- 11. For claiming the benefit of reservation under Backward Class category, the candidates should produce a caste validity certificate issued by appropriate Caste Scrutiny Committee. The candidates applying without caste validity certificate, if selected, will be appointed provisionally only after submission of proof of submission of documents to appropriate Caste Scrutiny Committee for caste validity as per G.R. No. BCC-2009/P.No.291/09/16-B dt. 05/11/2009 & G.R. No. BCC-2011/P.No. 1064/2011/16-B dtd. 12/12/2011.
- 12. For claiming the benefit of reservation under EWS, the candidates have to produce the Certificate issued by the appropriate authority as prescribed under Annexure-'A' enclosed to Maharashtra Government Resolution dated 12/02/2019.
- 13. MSEDCL reserves the right to rectify any inadvertent error or typographical mistake.
- 14. The appointments of all the SEBC category candidates are provisional and subject to outcome order from the Hon'ble Supreme Court of India in the SLP (C) No. 15701/2019 and any instruction by the GoM accordingly are received.
- 15. The selection of the candidates will be subject to further order in respect of Writ Petition No. 7038/2018 filed before the Hon'ble High Court, Nagpur.
- 16. Selected candidates are being informed by E-mail and SMS regarding documents verification. MSEDCL regrets inability to entertain any correspondence from unsuccessful candidates.
- 17. The candidates in the select list only (Not wait list) are instructed to report for document verification process at MSEDCL, Training & Safety Department, Chemry No.1, Eklahare, Near Guest House, Nashik on 04/02/2020 at 0930. In case documents verification is not completed on same date, it may continue on following day. The candidates will have to make their own arrangements for lodging and boarding.
- 18. Selected candidates are to upload necessary documents on the link given below by 31st January, 2020.
- 19. The candidates should bring all relevant documents in original for this document verification process. It is the responsibility of the selected candidates to produce and submit all relevant documents as mentioned below i.e. list of documents.
