## Circular

Sub: Revised Guidelines for releasing new Agriculture connections under DDF scheme.

Ref: 1) Circular no CE(Dist)/RE/Ag pump/4900 dtd 12.02.2014

2) Circular no CE(Dist)/RE/Ag pump/3030 dtd 30.01.2014

Guidelines were issued vide circular no CE(Dist)/RE/Ag pump/3030 dtd 30.01.2014 for releasing new Ag connections under DDF and non DDF (CC & RF) scheme.

The facility for releasing new Ag connections under Non DDF (CC & RF) scheme has been already withdrawn vide circular under ref (1)-Clause No 2. Directives for releasing Ag connections under DDF scheme were also issued vide the same circular as:

- "For getting the Ag connections under DDF scheme, applicant will have to apply online in the portal available on MSEDCL's website.
- All such applications received under DDF scheme will be sanctioned by concerned Zonal Chief Engineer ".

Now many representations from the prospective Agricultural consumers & public representatives are received demanding faster release of Agricultural connections under DDF scheme.

After review of the representations received for releasing Ag connections under DDF scheme the clause no 4,5,6 of circular under reference (1) is modified as below.

- All such applications received under DDF scheme will be sanctioned by concerned Superintending Engineer (O&M) Circle.
- Superintending Engineer (O&M) Circle will ensure the source of material utilized & quality of the material as well as method of construction.
- Superintending Engineer (O&M) Circle will also ensure the feeding of NSC after releasing of new Ag connection in the IT system.

All other instructions issued in this matter vide previous circulars will remain same. The above guidelines issued vide this circular will come in force with immediate effect.
