

With reference to above cited subject, it is to state that in the past, MSEDCL was procuring various ratings of Dist Transformers as per IS:1180 (Part I and Part II):1989. As per Gazette Notification of Ministry of consumer affairs Food and public distribution dtd 19.07.2014 the IS:1180 (Part I and Part-II) :1989 is cancelled and IS:1180 (Part I) :2014 is enforced from 01.02.2016. Further as per Gazette Notification of Ministry of heavy Industries & Public enterprises, Govt of India on dtd 07.08.2015, it is mandatory to procure energy efficient transformers of Level 1, 2 ,3 as per IS:1180 (Part I) :2014 with BIS certification mark & all field officers are informed accordingly.

In view of above, due to non availability of sufficient supplier in the field for fulfilling the requirement of energy efficient level – I distribution transformers for all schemes of MSEDCL, Competent Authority has accorded his approval to allow the field offices to purchase the Dist Transformers of energy efficient level-1 as per IS:1180 (Part I) :2014 from following two firms in addition to already approved vendors, in other schemes.

- 1) M/s. Fairdeal Transformers & Switchgears Pvt. Ltd., Guna
- 2) M/s. Mohini Transformers Pvt. Ltd., Indore

As per the notification issued by Ministry of Power vide Gazette Notification dtd 17.02.2017 100kVA,11/0.433 kv Energy Efficient level-1 dist transformers as per IS:1180 (Part I) :2014 can be procured/ allowed upto 30.06.2017. The above instructions are valid upto 30.06.2017 only. From 01.07.2017 procurement of Dist transformers shall be as per Gazette Notification issued by Ministry of Power dtd 16.12.2016.
