**CIRCULAR**

**Sub :-Timely disposal of scrap / obsolete materials lying at various zones through e-auction**



The disposal of material which have outlived its usefulness and declared as scrap, is required to be carried in a timely manner. Scrap material occupies useful space and there is every possibility of revenue leakage due to theft / deterioration etc. E-auction of scrap and obsolete material will not only generate the additional revenue but also will create space in stores for its optimum utilization. As such directives to the effect have already been issued by the Material Management Cell from time to time in respect of the aforesaid matter. However it has been observed that huge quantity of scrap material / obsolete material such as distribution transformers, cables, conductors, poles etc are still lying at various stores and at sites.

Therefore Competent Authority has directed to take review on scrap material at discrete level zone/circle/division level on Immediate Basis & e-auction of present balance scrap material should be carried expeditiously and on priority. Therefore considering the heavy volume of scrap material currently available at respective Store / site, it is directed to dispose off the same through e-auction on or before 30/10/2016. Henceforth for the scrap material accumulated from 01 September 2016, the e-auction shall be carried on quarterly basis.

All field officers are requested to follow the circular scrupulously.
