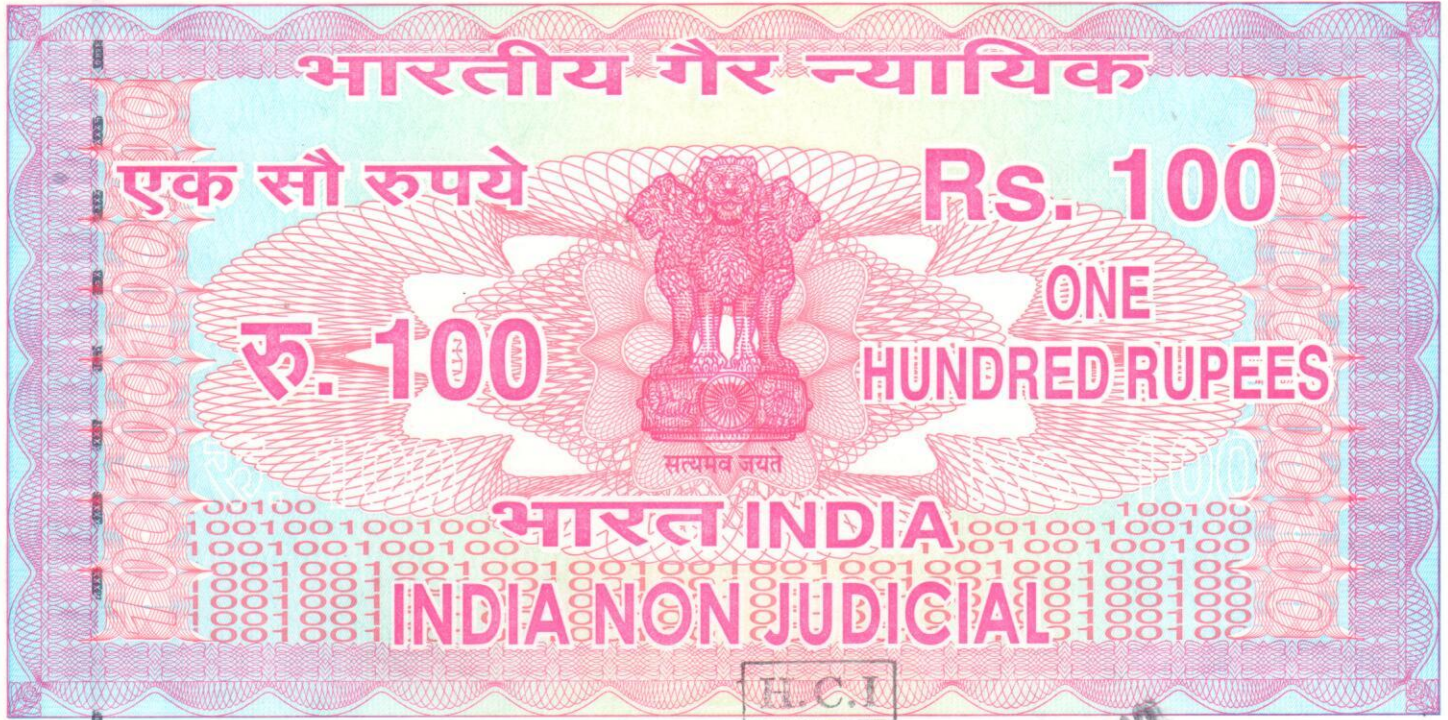

MahaOnline intends to offer its services through its portal [www.mahaonline.gov.in](http://www.mahaonline.gov.in) or any other website as may be mutually agreed by both the parties to this Agreement in future. MahaOnline in its capacity has an 'Agency Network' of Village Level Entrepreneurs (VLEs) across all Districts in state of Maharashtra for delivery of G2C(Government to customer) and B2C(Business to customer) services. The territory in the Divisions of MSEDCL is as per **Schedule -IV** to the Agreement.

WHEREAS Agency intends to provide an efficient and easily accessible bill payment collection services to the MSEDCL for the collection of bill payments from the Customers on behalf of MSEDCL (as defined below); throughout Maharashtra under this agreement as per **Schedule -IV** and

WHEREAS, MSEDCL wishes to avail of the services of Agency Network (as defined below) to facilitate payments being received from its Customers with respect to the energy bills issued by MSEDCL to its consumers.

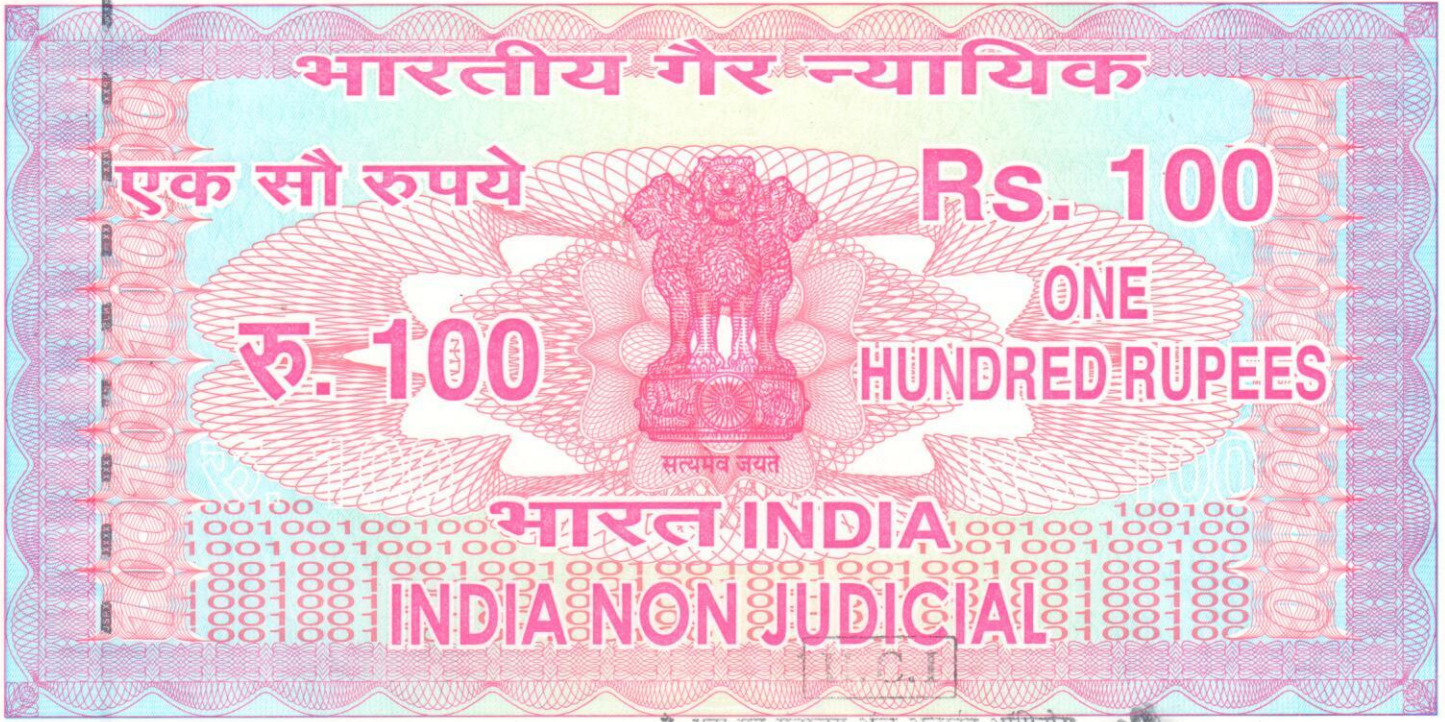
**NOW, THEREFORE**, in consideration of the mutual premise, covenants and upon the terms and conditions as set out herein, the parties have agreed to as follows:

## 1.0 DEFINITIONS

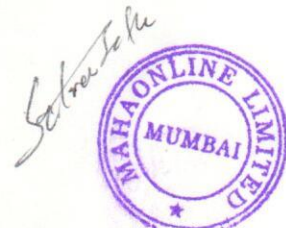
1.1 Definitions in this Agreement (including the recitals hereof), unless there is something inconsistent with the context, the following capitalized terms and expressions shall have the meaning set forth hereinafter:

- a) 'Affiliates' shall mean with respect to any Person, any other Person directly or indirectly controlling, controlled by, or under direct or indirect common control with, such Person; and any officer, employee, agent, sub-contractor, or representative of such Person.
- b) 'Agreement' shall mean this MSEDCL Agreement together with the Schedules hereto and shall include any modification and alternations hereto, made in writing, after the date of execution of this Agreement;
- c) 'Bank Account' shall have the meaning set forth in Section 2.4(a);
- d) 'Banking Day' shall mean a day (other than Sunday and bank holidays) on which banks are open for normal banking business;

- e) **'Bill'** shall mean such bills issued by the MSEDCL in respect of which Agency has agreed and authorized by MSEDCL to provide the Services;
- f) **'Cheque'** means any cheque, demand draft, pay order or any other similar instrument drawn on any bank in the Territory and is eligible for local clearing.
- g) **'Collectable Amount'** shall mean, with respect to a Bill, the amount to be collected by Agency from the Customers, and such amount shall include (a) the full amount of the Bill, including any late payment or other charges as may be stated on the Bill.
- h) **'Collected Amount'** shall have the meaning set forth in Section 2.3.
- i) **'Confidential Information'** shall have the meaning set forth in Section 8.1.
- j) **'Core Services'** shall mean such services to be provided by Agency to the MSEDCL as are set out in **Schedule-I**;
- k) **'Customers'** shall mean such consumers of the MSEDCL ;
- l) **'Day Collection'** shall mean the aggregate of the Collected Amount, excluding the Service Charges, received by the VLEs Network during any Working Day;
- m) **'Dispute'** shall mean and include any difference arising out of clauses of this agreement and non performance of any party.
- n) **'Due Date'** shall mean the date by which any Party is required to pay any sum of money to the other Party, as per the terms of this Agreement;
- o) **'Agency Network'** shall mean the VLEs (Village level entrepreneurs), VLEs, kiosks, outlets, channel partners Network and Terminals set up by MahaOnline Ltd as well as by existing and upcoming SCAs (Service Center Agency) including Sangram Kendras (also called as Gram Seva Kendras - GSK) and Setu Kendras, for providing G2C and B2C Services;
- p) **'Form of Payment'** shall mean cash and as may be prescribed by the MSEDCL from time to time for the payment of the Collectable Amount by the Customer, and as stated in Schedule 1 hereto;
- q) **'IPR'** shall mean all intellectual property rights including but not limited to trademark, copyright, and patent;
- r) **'Monthly Invoice'** shall have the meaning set forth in Section 3.2

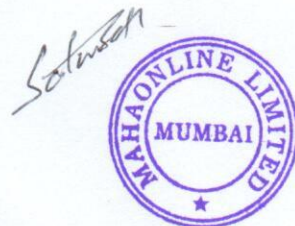




- s) **'Optional Service'** shall mean such optional services as may be provided by Agency at the request of the MSEDCL, on such terms and conditions as may be agreed between the Parties, and as set out in **Schedule-I**;
- t) **'Parties'** shall mean Agency and the MSEDCL and 'Party' shall mean either of them, as the case may be;
- u) **'VLEs'** shall have the meaning set forth in Section 2.1(a);
- v) **'VLEs Network'** shall have the meaning set forth in Section 2.1(b);
- w) **'Services'** shall mean the Core Services and / or the Optional Services provided by Agency to the customers on behalf of MSEDCL and Agency has been authorised to provide the same by MSEDCL ;
- x) **'Service Charges'** shall mean the amount, as described in Schedule 2, to be paid by the Customer to Agency in respect of the provision of Services;
- y) **'Service Commencement Date'** shall have the meaning set forth in Section 1.3;
- z) **"Service Fee"** shall mean the fees payable by the MSEDCL to Agency for providing the Services, and as set out in **Schedule II**;
- aa) **'Terminals'** shall mean certain multi-function terminals and ancillary equipments to be used for providing Services;
- bb) **'Territory'** shall mean all Common Service Centres (Maha eSeva Kendras) / Sangram Centers (Gram Seva Kendras) / Setu Centers throughout Maharashtra and as per schedule IV
- cc) **'Transaction Data'** shall have the meaning set forth in Section 2.5(a).
- dd) **'Working Day'** shall mean each day the VLEs Network is open exclude Sundays, second and Fourth Saturday and public Holidays for the conduct of the normal business of the respective VLEs .
- ee) **"Person-in-charge"** shall mean the Company's nominated representative for the purpose of carrying out the Inspection for the works being executed by contractor in relation to this work order.
- ff) **"Collection Day"** shall mean the all days in the year except specified days, i.e. 26<sup>th</sup> January, 15<sup>th</sup> August, 2<sup>nd</sup> October, Holi Festival & Diwali Festival or any other day which is define as specified day by the person in-charge.

- a) References in this Agreement to Sections, Articles, or Schedules are references to Sections, Articles, or Schedules, respectively, in or to this Agreement unless otherwise specified.
- b) Words importing the singular shall include the plural and vice versa, words importing a gender include every gender, and references to person include bodies corporate and unincorporated.
- c) Words 'include', 'includes' or 'including' shall be deemed to be followed by the words 'without limitation'.
- d) In the event an ambiguity or question of intent or interpretation arises, this Agreement shall be construed as if drafted jointly by the Parties, and no presumption or burden of proof shall arise favouring or disfavouring any Party by virtue of the authorship of any provision of this Agreement.
- e) The section and paragraph headings contained in this Agreement are for reference only and shall not affect in any way the meaning or interpretation of this Agreement.
- f) Except as expressly provided to the contrary herein, the body of this Agreement shall be read in priority to the Schedules.

### 1.3 Commencements and Term:

- a) This Agreement shall come into operation, on the date hereof and shall, unless terminated earlier in accordance with its terms, continue, in force for a period of **one year** which will be extended subject to satisfactory performance of the agency, The Parties shall have an option to review the Agreement as such terms and conditions as are mutually agreed upon.

## 2.0 PROVISIONS OF SERVICES BY AGENCY

### 2.1 Uses of Agents:

- a) Agency may perform its obligations under this Agreement by employing Village Level Entrepreneurs (VLE) appointed at various Common Service Centres and the performance of any such obligation by any VLE shall be deemed to be performance by Agency. Agency shall lay down proper procedures and service parameters for the VLEs to ensure that VLEs provide efficient services in a business like manner to the Customers. In event of any complaint by any Customer about the conduct of any VLEs the MSEDCL shall have the right to request Agency to take appropriate action against such VLEs; and Agency shall, upon reasonable investigation of the matter, take such action, as it deems reasonable in the circumstances of such case.
- b) Agency shall at the date of this Agreement provide the MSEDCL with a complete list of the VLEs and their locations (the 'VLEs Network'). Agency shall be at liberty to making changes at its discretion, to the

VLEs Network, and shall notify the MSEDCL of such changes. The Bills shall be accepted for payment only at the VLEs Network and no other place.

## **2.2 Promotions and Marketing of Agency Network:**

- a) Agency and MSEDCL (jointly or severally) shall take all reasonable steps to spread general awareness of the VLEs Network to Customers and potential users of the Services.
- b) Agency for the purpose of promotion may use all reasonable advertisement means; e.g. posters, pamphlets, banners etc.
- c) Agency shall be entitled to use IPR [royalty free] of the MSEDCL in any marketing or promotional material relating to Services or in the receipt issued by the Agency Network. Agency shall be entitled to also include the name of the MSEDCL in any of its client list, which it produces for any marketing or promotional activity of Agency. The use of the name of the MSEDCL by Agency shall not amount to any guarantee or assurance from the MSEDCL on the quality of services of Agency.

## **2.3 Collections of Bills from the Customers:**

- a) Agency will not accept any Non-Energy Demand Notes or Enforcement Bills from the customer of MSEDCL.
- b) Receipts through printer will be provided by the Agency to each consumer.
- c) No Part-Payment will be accepted by the Agency ; however excess payment may be received & remitted to MSEDCL.
- d) After Due-Date, the payment will not be accepted.

## **2.4 Deposits of Bills with the MSEDCL :**

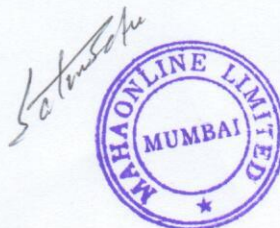
- a) Agency shall, by the end of the next Banking Day, deposit the Day's Collection (cash) into such bank account of the MSEDCL through RTGS/NEFT as is notified to Agency (the '**Bank Account**') or deliver it to such person as may be authorized in writing by MSEDCL for this purpose.
- b) Fund transfer and activity analysis shall be according to **Schedule -III**

## **2.5 Transactions and Payment Advice:**

- a) Agency shall provide access to MSEDCL to its portal through an admin login so as to enable MSEDCL to check the data relating to the Day Collection ('Transaction Data') at any time. This admin login access will be provided by the Agency before starting the collection work.

### 3.0 SERVICE FEES AND OTHER PAYMENTS

#### 3.1 Service Fees and Charges:

- a) In consideration for providing the Services, the MSEDCL shall pay to Agency, the Service Fee in accordance with **Schedule-II**.

- 3.2 Agency shall provide within 5 (five) working Days of the end of any calendar month, a consolidated monthly statement of the Service Fee, with a break-up of the fees for Core Service and Optional Services, due from the MSEDCL to Agency for the Services provided in such month (the 'Monthly Invoice'). The Monthly Invoice shall be submitted to Help Desk, H.O., MSEDCL and shall be due for payment by the MSEDCL till the month end.

- 3.3 Any changes in the tax provisions presently applicable to the Services, including changes in service tax, sales tax, revenue stamp charges, or any other government levy in the future shall be on the account of and shall be borne by MahaOnline and/or MSEDCL as may be applicable as per government regulations. and MSEDCL shall not be responsible for the cost of ensuring that all revenue stamps which are required to be affixed on any Bill and/or receipt is so affixed.

#### 3.4 Security Deposit:


- a) Initially, Agency will furnish the Security Deposit of Rs **2,00,000/- (two Lac) per division in cash/BG** only.
- b) The total Security Deposit to be paid by the Agency shall be equivalent to 3 days average cash collection of preceding quarter. A review of adequacy of the security deposit will be taken every six months by MSEDCL and any short fall will be recouped by the Agency.
- c) MSEDCL will pay interest annually on security deposit paid by the agency in the form of cash/DD/Cheque at the rate equivalent to interest on consumer's security deposit prevailing at relevant time and subject to change from time to time.
- d) The security deposit shall be refunded within three months after expiry of the contract or settlement of accounts whichever is later.

### 4.0 OBLIGATIONS OF AGENCY

#### 4.1 Agency agrees to:

- a) Collect precise Payment Amounts as reflected in the bills, from the Payment Account of the Consumer if the presentment of the relevant bill payable is made by the MSEDCL, **BY CASH ONLY** and such collection is required by the MSEDCL, or otherwise collect such amount as is authorized under **Schedule-I** of the Agreement.

- b) Accept Payment Instructions from the Consumers up to a date that is mutually agreeable between the Parties for payment of the bill and intimated prior in writing to Agency by MSEDCL.
- c) Give access to a consolidated statement and customised MIS as required by MSEDCL on a daily basis, showing such details of collection as are agreed by Parties herein.
- d) MSEDCL is in process of developing a mechanism where all the agencies associated with Helpdesk HO, shall be integrated to its portal. In this regard Agency shall have to co-ordinate with HO IT for integration as per requirement of MSEDCL and for the same and develop proper mechanism so as to integrate with the MSEDCL portal and adhere to terms & conditions relating to the same as shall be communicated at appropriate time.

## **5.0 OBLIGATIONS OF THE MSEDCL**

### **5.1 The MSEDCL agrees to:**

- a) Furnish to Agency; confirmation of any payment received from Agency in its designated collection account and credit of the same to the Consumers' account maintained by it. This confirmation shall be provided by next banking day or the Parties may determine as.
- b) If MSEDCL does not credit the account of the Consumer; despite receipt of payment from Agency within the expiry date of the concerned bill or within the extended periods, MSEDCL shall inform Agency and Consumer, through Agency, of the reasons thereof and that Agency shall not be in any way liable / responsible to the Consumer, MSEDCL and/or any third Party. The expenses for the same will bear by MSEDCL.
- c) If at a later date, it is found that a wrong credit is given to the MSEDCL, the MSEDCL shall within Seven (7) working days of receipt of intimation of the same from Agency, identify/rectify the credit, notwithstanding any payment confirmation given by MSEDCL to Consumer.
- d) The MSEDCL accepts that all the records of Agency generated by the transactions arising out of the use of the Service, (including the time the transaction is recorded) shall be conclusive proof of the genuineness and accuracy of the Consumer's transaction.

### **5.2 Recording of Complaints:**

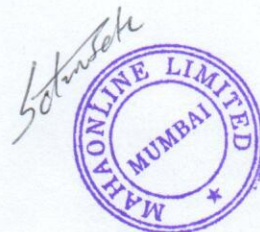
- a) The MSEDCL agrees with Agency to use all reasonable endeavours to record any complaints that are received by the MSEDCL from Customers in connection with the Services and to pass details of any such complaints to Agency as soon as reasonably practicable. The MSEDCL also agrees to consult Agency and use all reasonable endeavours to include appropriate questions concerning the quality of the Services provided by Agency in any relevant Customer surveys that the MSEDCL may choose to conduct; provided, however, that Agency shall not be deemed to be in breach of any provision of this Agreement merely on the basis of the findings or results of such surveys.

- a) MSEDCL shall receipt of the Transaction Data as set out in Section 2.5(a) If however the MSEDCL finds any error in such Transaction Data, it must inform Agency of the same as soon as practical on the receipt of the Transaction Data, and any such perceived error shall be resolved mutually by the Parties.

## **6.0 REPRESENTATION OF PARTIES**

### **6.1 Each Party represents and warrants to the other Party that:**

- a) Representation by Agency that it is a duly registered company and authorized to undertake the business of the electronic bill presentment and payment service.
- b) That each Party has full corporate power and authority to enter into this Agreement and to take any action and execute any documents required by the terms hereof; and that this Agreement has been duly authorized by all necessary corporate proceedings, has been duly and validly executed and delivered by each such Party, and is a legal, valid and binding obligation of such Party, enforceable in accordance with the terms hereof; and that the executants of this Agreement on behalf of such Party have been duly empowered and authorized to execute this Agreement and to perform all its obligations in accordance with the terms herein set out.
- c) That all services rendered and operations conducted pursuant to this Agreement shall be in compliance with legislations, statutes, ordinances, regulations, administrative rulings and requirements of law.
- d) The execution of this Agreement and the performance of its obligations hereunder do not:
- (i) Require the consent of any person other than the party; and
  - (ii) Violate any Governmental rule, permit, consent or any provision of the laws the party is subject to.
- e) All information provided by the Party, whether stated herein or in any other document provided to the other Party during negotiations for the execution of this Agreement, is true, complete and accurate in all respect.

## **7.0 EFFECTIVE DATE & VALIDITY**

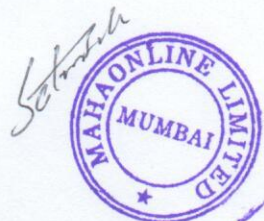
- 7.1 This Agreement shall become effective for all purposes and intents from the date of execution of this Agreement & shall be in force for a period of **one year** unless terminated earlier. This agreement shall be for provision of services throughout Maharashtra. After expiry of the validity period of this Agreement, it may be extended / renewed / replaced for such further period on such terms and conditions as may be mutually agreed to between the MSEDCL and the Agency. If no agreement is reached between the parties before the expiry of this Agreement, the said Agreement shall automatically lapse after the expiry.

## **8.0 CONFIDENTIALITY:**

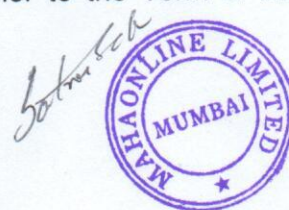

- 8.1 Each Party shall observe the strictest confidentiality in respect of all matters relating to the negotiation, execution and implementation of this Agreement. All the information under this Agreement will be treated as strictly confidential and shall not be disclosed to any third Party unless otherwise agreed to by the non-disclosing Party. For any such breach, the non-breaching Party shall be competent to seek legal remedies for injunctive relief and it shall not be liable for any consequences, whatsoever, in any manner.
- 8.2 MSEDCL and Agency shall mutually decide for any public announcement or make or release any statement or bulletin to the press or to any other medium of information in respect of any matter relating to this Agreement.
- 8.3 Each Party shall, and shall cause its Affiliates to, hold in the strictest confidence any information obtained in the course of negotiations relating to this Agreement or as a result of entering into or performing this Agreement that relates to the subject matter and the provisions of this Agreement. Each Party agrees to hold, and to cause its affiliates to hold, in strictest confidence, and not to use for its or their own purposes, all non-public, confidential or proprietary information. For the purposes of this the following shall not be regarded as Confidential Information: a) such information as is necessary to enable such Party to perform its obligations under this Agreement; (b) such information as is required by law or any regulatory body (c) any information that is in the public domain or enters the public domain.
- 8.4 In the event of any breach of this provision, breaching Party shall indemnify the non-breaching Party against any loss, cost or damage or claim by any party in respect of such breach.
- 9.0 INDEMNIFICATION**
- 9.1 Either Party shall indemnify at all times the other Party and hold harmless all directors and employees of the other Party against any claims, law suits or damages occurring as a result of the award of this Agreement or due to the act, omission, commission, mistake, operation, maintenance and administration of this Agreement and against costs and expenses, if any incurred by us in connection therewith and prejudice to make any recovery.
- 10.0 NON-EXCLUSIVITY**
- 10.1 The award of this Agreement to Agency shall not preclude the MSEDCL from awarding the same order for similar work at any rates, or on any terms and conditions to other party or parties. This agreement shall not be deemed to constitute a partnership, joint venture or employer & employee relationship. Both Parties are entering into this Agreement and provide services as per this Agreement on non-exclusive basis.
- 11.0 TERMINATION**
- 11.1 On the expiry of the term of this Agreement, this Agreement shall stand automatically terminated unless extended by the parties in writing.
- 11.2 The Agreement may be terminated at any time prior to the Term of this Agreement:





a) By the mutual written consent of the parties.

b) Either party may terminate this Agreement by giving one (1) month prior notice in writing to the other party without assigning any reasons for the same.

c) Either party may terminate this Agreement by giving one (1) month prior "cure notice" in writing on a breach of any term(s) and condition(s) of this Agreement by other party for rectification / clarification the same. Failing which Either Party shall terminate this Agreement immediately.

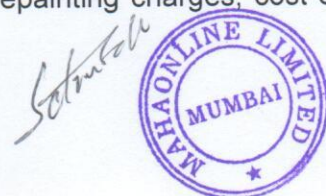
**11.3** Upon the passing of a resolution of the winding up of the other Party (other than a resolution for the voluntary winding up of the other Party for the purposes of reconstruction or amalgamation), or the winding up or dissolution of the other Party by a court of competent jurisdiction.

**11.4 Consequences of Termination:**

- a) Each Party will within 15 working days pay all amounts as shall have accrued and become payable to other Party as at the date of termination, if any.
- b) Agency shall immediately stop procuring services mentioned in this Agreement on behalf of MSEDCL.
- c) The Parties agree that, within 30 (thirty) days of termination, Receiving Party will return to the Disclosing Party any Confidential Information received under the Agreement or at the sole option of such Party destroy and certify destruction of such Confidential Information. Any knowledge which comes within the knowledge of the other party shall not be used to the detriment and/or disadvantage of the other party.
- d) Both the Parties shall forthwith cease and desist from using the Tradename(s), Trademark(s), Logo and all other intellectual properties of other Party in connection with this business. Failure to do so shall make the breaching party liable to pay damages without prejudice to other remedies at law.
- e) The termination or earlier determination of this agreement for any reasons whatsoever shall not affect the rights and liabilities of the parties prior to the termination.
- f) Upon termination either Party shall remove all signboards, banners, glow signboards, all other Intellectual Property of other Party from its outlets / premises and also all such material, which will indicate any association with other Party and *vice versa*.
- g) Upon termination, either Party shall return to POPs, other manual, and/or any other advertising material the terminal and/or software supplied by other Party, if any and *vice versa*.
- h) Either Party shall have no right of claim or entitlement of any kind of compensation or any other payment towards termination of this Agreement other than and legally enforceable dues and outstanding and other Party shall not, under any circumstances, be liable or responsible, individually or collectively or fully or partly, for any kind of loss or expenses incurred by either Party which includes but not limited to loss of profits, opportunity cost, interest on investment, cost of furniture & fixtures, electrical fittings, painting, decorating, professional fees paid to architects, designer, engineer etc, including repainting charges, cost of

## **12.0 DISCLOSURE OF CONSUMER DETAILS**

- 12.1** The MSEDCL agrees that Agency shall hold and process the personal and bill details of the Consumers and all other information concerning his Payment Account on computer or otherwise in connection with the Service as well as for analysis. The MSEDCL also agrees that Agency may disclose such information as may be reasonably necessary for carrying out the Payment Instructions of the Consumers or for purposes of credit rating by recognized credit-scoring agencies or fraud prevention. Provided further that Agency may disclose information in compliance of statutory and regulatory requirements or in compliance with a legal directive and to its Affiliates with prior approval of the MSEDCL .

## **13.0 GOVERNING LAW AND ARBITRATION**

- 13.1** The provisions of this Agreement shall be governed by, and construed in accordance with Indian law.
- 13.2** Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled by arbitration in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996.
- 13.3** The arbitral tribunal shall composed of three arbitrators, one arbitrator to be appointed by each Party and the third arbitrator shall be appointed by such arbitrators.
- 13.4** The place of arbitration shall be Mumbai and any award whether interim or final, shall be made, and shall be deemed for all purposes between the Parties to be made, in Mumbai.
- 13.5** The arbitral procedure shall be conducted in English language and any award or awards shall be rendered in English. The procedural law of the arbitration shall be Indian law.
- 13.6** The award of the arbitrator shall be final and conclusive and binding upon the Parties, and the Parties shall be entitled (but not obliged) to enter judgment thereon in any one or more of the highest courts having jurisdiction. The Parties further agree that such enforcement shall be subject to the provisions of the Indian Arbitration and Conciliation Act, 1996 and neither Party shall seek to resist the enforcement of any award in India on the basis that award is not subject to such provisions.
- 13.7** The rights and obligations of the Parties under, or pursuant to, this Clause, including the arbitration agreement in this Clause, shall be under the exclusive jurisdiction of the courts situated at Mumbai.

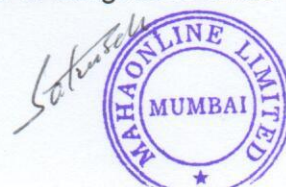
## **14.0 ASSIGNMENT**

- 16.1** Neither Party shall be considered in default of performance of its obligations under the terms of this Agreement or for indemnification provided for hereunder, if such performance is prevented or delayed for any cause beyond the reasonable control of the Party affected including war, hostilities, revolution, riots, civil commotion, strikes, lockouts, epidemic, fire, explosion, flood, earth-quake, act of God, any act of Government, or disruptions in or failure of telecommunication network or bank strike or any cause beyond the control of the concerned Party which could not have been foreseen or avoided by the exercise of due diligence provided that notices in writing, of any such event with necessary evidence that the obligation under the Agreement has been thereby affected or prevented or delayed, is given as soon as possible and in any event within 14 days from the happening of the force majeure event, and in case it is not possible to serve the notice within the said 14 days period, then within the shortest possible period thereafter without delay.
- 16.2** The Party affected by force majeure shall continue to perform the obligations under this Agreement, which are not affected by the force majeure event and may take steps as are reasonably necessary to remove the causes resulting in force majeure if within its control and to mitigate the effect thereof.
- 16.3** As soon as the cause of force majeure has been removed, the Party whose liability to perform its obligation has been affected shall notify the other Party the actual delay occurred in such affected activity.
- 16.4** In case of force majeure continuing beyond a period of 6 months, the Party whose liability to perform its obligation has been affected shall be entitled to terminate this Agreement.

#### **17.0 LIMITED LIABILITY**

- 17.1** Agency is only facilitator of service(s) on behalf of the MSEDCL. Therefore, the Agency shall not liable / responsible for any defect / deficiency / delay / damage(s) / losses to the customer(s) / consumer(s) / subscriber(s) of Service(s) or any third party.

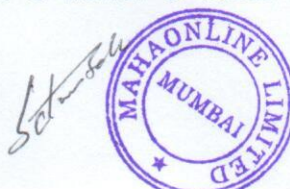
