Sub: Petition of Maharashtra State Electricity Distribution Co. Ltd. for approval of Business Plan for FY 2013-14 to FY 2015-16 .. Printing of Business Plan Petition (Case No.134 of 2012).

MSEDCL has filed a Business Plan Petition for FY 2013-14 to FY 2015-16 (Case No.134 of 2012) before the Maharashtra Electricity Regulatory Commission for approval. The said petition has been admitted by the Maharashtra Electricity Regulatory Commission (MERC) and as decided to conduct Public Hearing in respect of said Petition at Centrum Hall, 1st Floor, Centre 1, World Trade Centre, Cuffe Parade, Colaba, Mumbai -400 005 on Friday, 10 May 2013 at 11.00 AM in the state.

The Commission has directed MSEDCL to publish a Public Notice for inviting suggestions / objections from general public and consumers. Accordingly, arrangement has been made to publish a notice in leading daily news papers throughout the State and it is expected that the Notice will appear in the news papers on Monday, 8 April 2013. The said Public Notice is also being placed on the website.

As directed by the Commission, a copy of the Petition (Case No.134 of 2012) is to be made available, on demand, to general public & consumer against payment of necessary charges as shown below. However, the copy of the Executive Summary (in English as well as Marathi) is to be provided free of cost. It is requested that the instructions contained in the Public Notice in this regard may please be carefully followed and all the concerned should also be informed accordingly.
