## CIRCULAR

Sub: Applicability of Service Tax & closure of A/c 'A' & 'B' in respect of Major Stores.

Ref: 1) Amendment in Finance Act. Applicable w.e.f. 01.07.2012 2) No.CGM(CF)/Service Tax/MSEDCL/3317 dt. 06.10.2012 3) HR/MMC/Reorganization of Stores/5992 dt.11.10.2012

# 1. SERVICE TAX:

As per Finance Act Amendment atd. 20.06.2012 MSEDCL is required to deduct the applicable Service Tax and pay to Government Treasury up to 6<sup>th</sup> of next month on the newly allotted Service Tax number. As per letter under reference (2) the directives with detailed guidelines have already been issued to obtain Service Tax registration number for each accounting units i.e. Circle / Division and arrange to remit the Service Tax amount applicable for the payment released after 1<sup>st</sup> July 2012.

However, with effect from 5th November 2012 all Major Stores and the Store Centers were merged to various Division offices vide letter under reference No.3. Accordingly for the purpose of Service Tax liability, if the Service Tax Registration is not yet obtained in respect of any Major Store, then the liability of service tax payment is to be paid by the respective Division Offices where the Major Store and Store Centre have been merged. Further, if Service Tax registration number is obtained earlier by Major Store, then the Service Tax should be remitted in their respective Service Tax number till merging of Major Store.

## CLOSURE OF A/C 'A' & 'B':

As per letter under reference No. (3), Major Stores and store centres are merged in respective O & M Divisions under various Circles. In view of this it is directed to close the Account 'A' & 'B' immediately and transfer all the remaining balance to WM Section (H.O.), Mumbai With bank closing certificate. However, before closing the bank account it is to be ensured that all cheques issued are cleared and nothing is outstanding against these accounts. This activity is to be complied by concerned Division / Circle with whom the Major Store has been merged.

It may please be noted that it would be the responsibility of concern Circle Incharge to ensure that the registration of Service Tax and payment thereof in stipulated time and to close the A/c 'A' & 'B' of concern Major Store. These instructions should be followed scrupulosity to avoid further Statutory Complications.
