Sub:- Rate of interest on Consumer's Security Deposit for the year 2008-09

As per the provision No. 11.11 of MERC's (Electricity Supply Code and other conditions of Supply) Regulation 2005, the rate of interest, on consumers Security Deposit paid by cash / DD/cheques amounting to Rs.50/- or more against the energy bills, is to be paid as per the bank rate of the Reserve Bank of India.

The present rate of interest for the year 2008-2009 is @ Rs. 6% per annum.

Interest on Security Deposit against energy bill will be worked out accordingly for the year 2008-2009 and to be paid / adjusted as per rules.
