Sub: Extra un-recovered FAC amount to be billed for the period April 2009 to July 2009.

The Maharashtra Electricity Regulatory Commission has approved the recovery of unrecovered Fuel Adjustment Charges (FAC) of Rs. 579.39 Crs. through levy of extra FAC @ 38 Paise/kWh in the bills for November 2009, December 2009 & January 2010. As per the approval of Competent Authority, this extra FAC is to be recovered as under:

This extra FAC should be levied in addition to the regular FAC.

- 2. The bills of first cycle of November 2009 are already prepared, hence these consumers shall be levied extra FAC in the month of February'2010
