COMMERCIAL CIRCULAR NO. 13 8

Sub: Re-delegation of powers in respect of release of HT connections.

Ref: Circular No. 135 dated 13.05.2011.

The State Government vide its Resolution No. SAC 1093/CR-4445/NRG-5 dated 02.01.1995 has given full powers to all licensees for sanctioning the load without any upper limit.

MERC Electricity Supply Code and Standard of Performance are in force since 20.01.2005 in which specified voltage levels corresponding to load / contract demand and time bound policy of releasing the connections to the consumer have been mentioned. In order to maintain the time bound schedule of Standard of Performance (SoP) and to fulfill the power requirement of various consumers as per Appendix "A" mentioned under SoP Regulations No. 12, the existing delegation of powers have been modified / re-delegated by the Competent Authority of MSEDCL.

As per the powers conferred to the Managing Director, MSEDCL vide Admn. Circular No. 1 dated 29.09.2005, the Managing Director, MSEDCL in consultation with Director (Operations), Director (Project) & Director (Finance) has approved the redelegation of powers in respect of load sanction and the same has been issued to all concerned vide Commercial Circular No. 135 (No.Co.Ord.Cell/Re-delegation of power/15311) dated 13.05.2011.

In continuation of Circular No. 135 dated 13.05.2011, MSEDCL has further approved re-delegation of powers for:

i) Technical & Administrative sanction of estimate related to release of HT connection upto the level of 33 KV voltage to concerned S.E., O&M Circle.

ii) For execution of agreement for release of power to all HT connection is as follows:

S.No	Authority	Existing delegation of powers	Revised delegation of powers
01.	S.E. of concerned O&M Circle	2.5 MVA	No change
02.	C.E. of concerned Zone	Above 2.5 MVA	S.E. of concerned O&M Circle

All field officers are, therefore, requested to note the above changes and finalise the load sanction cases accordingly.

It may please be noted that the above re-delegation of powers are considered for speedy release of HT connections as per norms of MERC Standard of Performance.

Also, all concerned are directed to scrupulously follow the provisions of Circular No. 135 dated 13.05.2011 and this circular so as to ensure immediate release of connections. All other instructions / directives / circulars etc. issued by any of the field authority with regards to the issues covered in the two circulars (circular No. 135 dated 13.05.2011 and this circular) is superseded.
