Vide Corrigendum Commercial Circular No.63 dt. 11.09.07, considering the difficulties of the consumers, the Competent Authority had extended the last date for submission of the Certificate (HT I category – Continuous or Non-continuous) upto 10th Oct 2007.

Now it is decided to once again extend the date of submission of Certificate upto 12.11.2007, for consideration / to decide the eligibility for benefits of continuous industries for the period from $1^{\rm st}$ October 2006 to $30^{\rm th}$ April 2007. In case of failure of the consumers to submit the certificate, the provisions of Circular No. 52 dated 07.05.2007 will be implemented.

All other terms and conditions of Commercial Circular No. 52 dated 07.05.2007 will remain unchanged.
