Sub: Stoppage of Non- DDF CC&RF scheme for release of power supply to prospective consumers.

- Ref:** 1) Circular No. CE (Dist)/D-III/Circular/22197 dtd.20.05.2008.
2) Refund Circular No. DIST/D-III/Refund/Circular/39206 dtd.21.12.2009
3) Circular No. CE (Dist)/D-III/Non DDF CC&RF/5489 Dtd: 14.03.2018.

This office vide circular under reference (1) has circulated instructions/guidelines for release of supply to the consumers who opt for connections under Non Dedicated Distribution Facility (CC&RF). Further, guidelines have been issued under circular ref (2) for effecting the refund of legitimate expenditure incurred by such Non-DDF (CC&RF) consumers, by the way of adjustment of 50 % of the monthly bill amount till clearance of the total expenditure. Further as per circular at ref (3) it has been directed to temporarily withhold the refund and to verify all Non DDF (CC&RF) cases.

Now competent authority has directed as follows:

- (1) To stop the sanction of estimate under Non- DDF CC&RF with immediate effect.
- (2) The refund of Non- DDF CCRF shall be effected through system only after due verification of individual cases by Zonal office.
- (3) Estimates under DDF scheme shall be allowed only for RCI connections and shifting of HT/LT lines, DTC etc. WCR to be finalized on scrutiny of original bills of material used by consumer for the infrastructure commissioned under DDF works.
- (4) Undertaking about not claiming any refund for DDF work shall be obtained on Rs 200/- bond paper (copy of the undertaking is enclosed)

The instructions for withhold of refunds under Non DDF CC&RF as provided in circular at ref (3) shall become non-existent from the date of issuance of this letter, however the refunds be effected only after the same is verified / certified by CE(O&M) and the asset thereof is capitalized and accounted for.

SAMPLE UNDERTAKING FOR DDF

I Shri/Smt(name of the person with designation submitting the undertaking) do solemnly affirm that I am a duly authorized representative of M/s(name of industrial consumer/ applicant/ company /bodies/establishments ,etc) and authorized on behalf of M/s(name of consumer/ applicant/ company /bodies/establishments ,etc) to submit undertaking as follows:

- 1) I have seen, read and understood all the provisions of Hon'ble Maharashtra Electricity Regulatory Commission (Electricity Supply Code and Other Conditions of Supply) Regulations, 2005 especially provisions with relations to Dedicated Distribution Facility.
- 2) I Shri/Smt(name of the person with designation submitting the undertaking) on behalf of M/s(name of industrial consumer/ applicant/ company /bodies/establishments ,etc) voluntarily undertake to execute all relevant works as per the scope of work sanctioned by competent authority of MSEDCL against Sanction No , required to release power supply at premises site (address) of M/s under DDF (Dedicated Distribution Facility) scheme.
- 3) I further undertake to pay DPR cost sanctioned by competent authority of MSEDCL against Sanction No (applicable under 100 % DDF) or pay 1.3 % supervision charges on normative charges sanctioned by competent authority of MSEDCL against Sanction No (applicable under 1.3 % DDF).
- 4) I further undertake to relinquish the claim towards infrastructure for works being undertaken against sanction No under DDF scheme.
- 5) If any dispute arises during execution of work the same shall be resolved at our end and hereby indemnify MSEDCL for any such dispute. In case of dispute with MSEDCL, decision of MSEDCL authority shall be final.

6) After execution of work, we shall hand over all ownership of infrastructure created to MSEDCL.

The above undertaking is given at our own cost and risk with full knowledge of risk, legality and cost coverage and shall not claim any cost or compensation before any authority whatsoever against MSEDCL.
