CIRCULAR

Sub:- Enhancement in the limit of expenditure on hired vehicles for Flying Squads.

The instructions to hire the private vehicles for use of various offices in the field have been issued to curb the expenditure on purchase of new vehicles. The limits for the expenditure has been prescribed vide Adm.Circular No.85 dt.07.11.2006, Admn. No.140 dt.05.01.2008 , Admn No.302, dt.20.07.2011and Admn No.354, dt.05.09.2011 .Considering the steep hike in the fuel price, the limits of expenditure had been enhanced vide Admn. Circular No.364 dt.25.10.2011.The issue regarding enhancing the limit of expenditure on hiring of vehicles for Flying Squads was under consideration for sometime in past.

2. Now, considering the steep hike in the fuel price, the Managing Director in consultation with Director(Projects), Director(Operations) and Director(Finance) has accorded an approval to enhance the existing limits of expenditure on hiring of vehicles for Flying Squads as given below:-

The revised limits prescribed as per Sr.No.(1) above are equally applicable for the vehicles hired for Company's work.
