CIRCULAR

Sub: - Re-delegation of powers for technical sanction for works related to LT & HT connections under all schemes.

Ref: 1) Circular no. 23, Revision of Delegation of Powers Dtd. 04.08.2006.

Maharashtra Electricity regulatory commission vide its Electricity Supply code & Standard of performance has specified the voltage levels corresponding to load/contract demand & time bound policy of releasing the connection. In order to maintain the time bound schedule of SOP for releasing power supply to consumer & to avoid administrative delay in sanctioning, the existing Delegation of powers in respect of technical sanction of works related to LT/HT connections have been modified/re-delegated with the approval of competent authority.

As per the powers conferred to the competent authority i.e. The Managing Director vide Admn Circular no 1 dated 29.09.2005 has approved the modification/re-delegation of powers under Section - II (works), clause No.1(E)(v) of Delegation of power in respect of Technical sanction for works related to LT/HT connections. The revised limits are indicated as under.
