The undersigned is directed to refer to Ministry of Home Affairs OM No. 17/19/2018-Judl&PP dated 18th April, 2018 on the above mentioned subject. The State Legislature of Maharashtra has proposed amendment in Section 168 of the Electricity Act, 2003 through the above subject Bill.

- 2. The proposed Electricity (Maharashtra Amendment) Bill, 2018 has been examined in consultation with the Central Electricity Authority. The comments of Ministry of Power in the prescribed template (Annexure-I) are enclosed.
- 3. This Ministry has no objection to the proposed Electricity (Maharashtra Amendment) Bill, 2018 subject to following modification in the proposed provisions of the Bill:

"Notwithstanding anything contained in the Code of Criminal Procedure, 1973, no court shall take cognizance of an offence alleged to have been committed by an employee employed in connection with the affairs of the Maharashtra State Power Generation Company Limited, the Maharashtra State Electricity Transmission Company Limited or the Maharashtra State Electricity Distribution Company Limited, being the Government Companies, while acting or purporting to act in the discharge of his official duties under this Act or the rules or regulations made thereunder, without the previous sanction of an officer of the concerned Government Company Energy Department of Government of Maharashtra duly authorized in this behalf by it."
