**Sub:** Simplification regarding documents to be submitted along with application for Industrial power supply.

**Ref:** 1) Commercial Circular No. 245 dt. 05.08.2015  
2) Commercial Circular No. 187 dt. 15.02.2013  
3) GoI revised Notification (MSME) dt.24.01.2017

MSEDCL is implementing & promoting various GoM initiatives like Make in India & Ease of Doing Business. The focus of above initiatives is to give further expeditious & hassle free services to industrial consumer. MSEDCL has developed an online system in new connection process vide Circular under reference No. (2). Further, vide Circular under reference No. (1), numbers of documents to be submitted along with the application for power supply are reduced to only "Two" with provisions for uploading the documents. Accordingly, the prospective industrial consumers, shall now upload only following documents along with application for power supply,

- (1) Ownership Proof
- (2) Industrial Registration / DIC Certificate.

Earlier provision of Registration before setting up of an enterprise (i.e. The Entrepreneurship Memorandum (EM-I)) submitted by applicant are considered as Industrial Registration / DIC Certificate for new industrial connection. The Entrepreneurship Memorandum (EM-II), which was issued after an enterprise start commercial operation.

Now as per GoI revised Notification (MSME) dt.24.01.2017, issuance of EM-I has been stopped. Udyog Aadhar Memorandum (UAM) - registration has replaced Entrepreneurship Memorandum-II (EM-II) & Small Scale Industry registration for all purpose.

This Industry (UAM earlier EM II) registration is given after an enterprise starts commercial operation. As issuance of EM-I has been stopped, New industrial applicants are facing difficulty to get the 'UAM' registration which is required for getting power supply.

As per GoI Notification, it has been decided that, "the New electricity connection being pre-establishment /pre-operation requirement of the industries, the DIC registration / Udyog Aadhar Memorandum (UAM) shall not be insisted as pre-requisite for new connection and the connection shall be released based on the undertaking submitted in the application form by the new applicant."

The message to "submit the Udyog Aadhar Memorandum" will be displayed on such consumer's bill till submission / online uploading of the document. Also, these consumers will not be treated eligible for the subsidy benefit as per GoM GR if any. Monthly/quarterly released such new industrial connections list generated through IT shall be submitted to the Head Office of DIC for verification at their end.

All the field officers are hereby informed to refer the GoI notification under reference No. (3) and take note of above while processing / accepting new industrial application for power supply.

This is for further necessary action at your end.
