Prior approval for FAC from Jun-22 to Aug-22 is received as per Ref. No. 3 to 5. As per Hon. MERC prior approval vide Ref. No. 5 FAC from Jun-22 to Aug-22 will be billed to consumers for billing month Nov-22 to Jan-23.
