
Sub. : FAC to be billed for the billing Month of Sep-23

Hon. MERC has issued the MYT tariff order of MSEDCL on 30-03-2020. Accordingly the prior approval of MERC for charging of FAC to consumers is mandatory from the month April-20 as per tariff order dated 30-03-2020.

Prior approval for FAC from Apr-23 to Jun-23 is received vide Ref. No. 2 to 4. As per Hon. MERC prior approval vide Ref. No. 4 FAC will be billed to consumers for billing month Sep-23.
