**Extension to PD Amnesty Scheme-2022 (VDAY) No.02/2022**

**Sub:-** Extension to **PD Amnesty Scheme-2022 (VDAY)** for HT /LT Non AG consumers.

Considering the crisis of Covid-19 Pandemic & series of lock down for revival of PD consumers, Board has accorded approval for **PD Amnesty Scheme -2022 ( VDAY)** vide above mentioned references. As per the scheme all HT/LT PD Non AG consumers made permanently disconnected on or before 31<sup>st</sup> Dec-2021 were eligible in the scheme. The tenure of scheme was for 06 Months (from 1<sup>st</sup> March-2022 to 31<sup>st</sup> Aug-2022).

Various field offices informed that many consumers are requesting to extend the scheme and they have shown willingness to pay the PD arrears. Accordingly office note for extension was submitted for approval of competent authority. Competent authority has accorded approval for extension till Dec-2022.


**Following are the additional terms & conditions to take benefit of the scheme.**

- To avail the scheme benefit eligible consumer shall apply on or before 31<sup>st</sup> Dec-2022 through on line mode only.
- In case of one stroke payment the consumer shall pay the 95% for HT or 90% for LT of principal arrears plus 100% legal charges if applicable within 30 days of approval.
- In case of installment the consumer has to pay 30% down payment plus 100% legal charges if applicable within 07 days from date of approval
- For approved installments the balance EMI shall be paid on or before every month end irrespective of reconnection/ new connection.
- The consumers having approved applications on or before 30<sup>th</sup> Sep-2022 & remain unpaid shall paid the down-payment/ one stroke amount till 31<sup>st</sup> Oct-2022.The sub sequent the balance EMI shall be paid on or before every month end irrespective of reconnection/ new connection.

- Default of the same shall disqualify the consumer from the scheme & no benefits shall be given.

The other terms & condition will be remains same as per B&R circular mentioned in reference No.3.
