Sub: Applicability of Electricity Duty Exemption to Railway, Monorail and Metrorail Consumers as per Maharashtra Electricity Duty (Amendment) Act, 2023 through Notification issued by GoM dtd. 19/01/2024

Ref : GoM's Notification dt. 19/01/2024

The GoM, in exercise of powers conferred by Section 4 of the Maharashtra Electricity Duty Act 2016 (the principal Act) and of all other powers enabling it in this behalf, and to give amendment to this principal Act introduced Maharashtra Electricity Duty (Amendment) Act, 2023 published in Maharashtra Government Gazette issued on date 19/01/2024.

The GoM specified w.e.f. 19/01/2024 an exemption on Electricity Duty mentioned in column (4) of the table appended here on the consumption of energy mentioned in column (1) and (2) of the Table as mentioned below :-

Tariff Category of electricity bill.	Purpose of utilization of electricity supplied to various categories of consumers	Earlier Rates	Revised Rates

LT VII (B): LT - Public Services – Others	As per the Tariff Schedule of the Maharashtra Electricity Regulatory Commission- Railway/Metro/Monorail Stations, including Shops, Workshops, Yards, etc, if the supply is at Low/ Medium Voltage.	21%	Exempted
HT III - Railways/Metro/Monorail	As per the Tariff Schedule of the Maharashtra Electricity Regulatory Commission- This tariff category is applicable to power supply at High Voltage for Railways, Metro and Monorail, including Stations and Shops, Workshops, Yards, etc.	20%	Exempted

As per above GoM publication the exemption will be applicable w.e.f. next billing cycle for above category of consumers.

All Field Offices are requested to take note of above amendment Act and ensure the Exemption in Electricity Duty is enabled to above consumers as specified in GoM publication.
