Sub:- Payment of Stamp Duty for various instruments in accordance with the amended Maharashtra Stamp Act, 1958.

Ref.:- Maharashtra Ordinance No. XII of 2024 dated 14.10.2024.

With reference to the above subject, Revenue and Forests Department, GoM has vide Ordinance No. XII of 2024 dated 14.10.2024 amended Maharashtra Stamp Duty, Act 1958 and revised stamp duty payable on various instruments. The revised stamp duty payable on works contract is as given below:-

Sr. No.	Description of Instrument	Revised Stamp Duty
1	WORKS CONTRACT, that is to say, a contract for works and labour or services involving transfer of property in goods (whether as goods or in some other form) in its execution and includes a sub-contract	
a	where the amount or value set forth in such contract does not exceed rupees five lakh	Five hundred rupees
b	where it exceed rupees five lakh	Five hundred rupees plus 0.3 per cent. of the amount above rupees five lakh subject to maximum of rupees twenty five lakhs.

The copy of Maharashtra Ordinance No. XII of 2024 is attached herewith.

The revised stamp duty rates have come into force w.e.f. 14.10.2024.


It shall be henceforth ensured to execute contract agreements for works contract or any other instrument in accordance with the revised stamp duty rates.

The contract agreements or any other instrument executed from 14.10.2024 shall be checked for payment of proper stamp duty rates in accordance with the amendment.

In case of any short payment found in the executed instruments, necessary corrective action shall be initiated by the office that have executed agreements and ensure that all statutory obligations are complied by all offices.
