Subject:- Launching of Single Window Portal for Renewable Energy Projects under GoM Renewable Energy Policy -2020.

Ref.:-1. RE Policy- 2020 vide GoM GR No. Apau-2020/Prs.Kr.137/Urja-7, dtd.31/12/2020.

- 2. Methodology for Re Policy- 2020 vide GoM GR No. Apau-2020/Prs.Kr.137(A)/Urja-7, dtd.11/05/2022.
- Government of Maharashtra has declared the Renewable Energy Generation Policy 2020 vide Govt. Resolution No. Apau/Pro.No.137/Energy-7, Dated31/12/2020. The target of setting up 17360 MW capacity renewable energy projects has been fixed under this policy. Registered Companies, Local / Civic bodies, Government Organizations, Partnership Organizations, Private Individuals, Semi-Government Organizations, Co-operative Societies, Farmer's Groups are permitted to set up projects under this policy.
- According to GoM RE Policy- 2020, MEDA in association with MSEDCL, MSETCL, Chief Electrical Inspector, SLDC has developed 'Single Window Web Portal' (for ease of doing business) like the 'Maitri' Portal of the Industries Department to obtain permissions, approvals, consents etc. from various departments of the State Government for installation and commissioning of renewable energy projects.
- In order to speed up the entire process and bring transparency in the process, in coordination with all the relevant Government Departments, the process timeline is minimized at each step/stage to the extent possible.
- It is expected that, this Single Window Portal will streamline the entire process, minimize time line to the stake holders in their approval process and ultimately result in promotion of RE projects in Maharashtra State.
- The said Single Window Portal will be live from 1st December, 2022. The Project Developer/Holder will apply through online to obtain approvals/ permissions from various departments viz. MEDA, MSEDCL, MSETCL, Chief Electrical Inspector, SLDC etc. under the MEDA Single Window Portal and the entire process of approvals / permissions will be done through online system only. The live Single Window Portal link will be available on https://www.mahaurja.com landing page top, right hand side on 1st December, 2022.

- Any new applications for all RE projects will not be accepted from 1st December, 2022 by
 offline. For already approved Grid Connectivity cases, the provision to upload in portal
 will be made available in due course of time.
