MNRE sanctioned 2.75 lakhs offgrid solar pumps installations in PM KUSUM B scheme to MSEDCL as SIA. GoM also announced to install 5 lakhs offgrid solar pumps installations in "Magel Tyala Saur Krushi Pump/ PM KUSUM B" Scheme.

The pre-dispatch inspection of solar pumps and allied materials for vendors awarded contracts for 3 HP, 5 HP, and 7.5 HP Off-Grid DC Solar Photovoltaic Water Pumping Systems is currently conducted after the vendor raises a call to MSEDCL. The pre-dispatch inspection of solar pumps and allied materials is currently carried out by Testing Division Executive Engineers.

Now, Competent Authority has approved the authorization of Circle EE (Adm) and Zone EE (Adm) in addition to EE testing division, to conduct pre-dispatch inspections of solar pumps and allied materials for vendors awarded contracts under the PM KUSUM B scheme.

The Circle Testing Unit will provide comprehensive training to EE (Adm) of Circle offices and EE (Adm) of Zone offices on pre-dispatch inspection procedures for solar pumps and allied materials.

It is requested to follow these guidelines scrupulously with immediate effect.
