Sub: Vendor approvals for IPDS/DDUGJY/Infra projects by Corporate Office.

- Applicability of approved GTP/Drawing/Type Test reports of various major material from Corporate office to all ongoing projects of MSEDCL including DDF/ Non-DDF schemes.

2) Directives in the meeting dated 27.12.2017 with transformer manufacturers

At Corporate Level, vendor approvals are issued for various major materials such as Distribution Transformers, Switchgear (GIS/AIS), Power Transformers, Distribution Box, LT/HT Feeder pillars, Relays, Meters, Capacitors etc, after verification and scrutinizing GTP, Drawings & Type Test reports in light of relevant IS/IECs and MSEDCL technical specifications and duly approved from Competent Authority.

It is observed that, some field officers are insisting manufacturers of above material for approval again from their office for utilization of above material under DDF/Non-DDF schemes/projects.

In order to avoid repetition of works and fast implementation of projects, this is to inform you that recently approved GTP, Drawing and Type test reports of all major materials under IPDS/DDUGJY/Infra Plan projects from Corporate Office shall be considered for all other schemes as well as DDF/Non-DDF projects, except for Distribution Transformers & Power Transformers.

The vendors approved for supply of Distribution and Power transformers under IPDS/DDUGJY projects by corporate office, as per PGCIL technical specification, after verification and scrutiny of GTP, Drawings and Type Test Reports in light of PGCIL technical specification shall be considered for IPDS & DDUGJY projects only.

However, the vendors approved for supply of Distribution transformers under IPDS/DDUGJY projects from corporate office, as per MSEDCL technical specification, having Maroon colour as per PGCIL technical specifications are valid for all ongoing projects in MSEDCL and DDF/Non DDF schemes by replacing colour to Air Craft Blue (shade no 108) as per IS 5.

The vendor approved for supply of Distribution & Power Transformers for Infra plan projects by corporate office as per MSEDCL technical specification, after verification and scrutiny of GTP, Drawings and Type Test Reports of Distribution Transformers & Power Transformers in light of MSEDCL technical specification and relevant IS. The vendor approved for Distribution & Power Transformers as per MSEDCL specifications shall be considered for DDF /Non DDF and other ongoing projects except IPDS and DDUGJY projects.

Further, all field officers are hereby instructed as follows:

- 1. The approved GTP, Drawings & Type Test reports, shall be valid till 5 years from the date of issue of type test reports. If validity of type test reports for a particular material is over, then the approval for that particular material will cease.
- 2. However, each material shall be accepted only by carrying out acceptance / routine tests at manufacturers works to ascertain major technical parameters as per MSEDCL technical specifications/PGCIL specifications and relevant IS/IECs by Executive Engineer (Testing) or Executive Engineer (O&M) level officers and not below the rank of Additional Executive Engineer.
- 3. The MSEDCL latest Technical Specifications of materials are available on MSEDCL web site.
