Clause 1.3	<p>PERIOD OF COMPLETION:</p> <p>The Works shall be completed in its entirety within Three (03) months from the Start Date, which shall be the date of issue of the LOA</p> <p>WORKS GUARANTEE (DEFECTS LIABILITY) PERIOD:</p> <p>The Works, Plant and Equipment supplied under the Contract shall be guaranteed against defects in materials, workmanship and manufacturer's defects for a period of twenty four (24) months after completion and acceptance by the Employer.</p> <p>As stated in the Conditions of Contract, the Works will be taken over in Turnkey project. The Guarantee Period will commence from the date of issue of the Taking-Over Certificate for the last Feeder/ Section by the Employer's Representative following successful completion of the pre-commissioning (test charging) activities for that Feeder/ Section. Clause 41.1	<p>SECURITY DEPOSIT:</p> <p>Within 14 (fourteen) days of the date of issue of the Letter of Acceptance, the successful bidder shall furnish a Security deposit in the amount of 5% (Ten percent) of the Contract Price, excluding the cost of GST Tax and Provisional Sums (if any), or in such other amount as the Employer may decide if the bid of the successful bidder is found to be seriously unbalanced or substantially below the Employer's estimate of the cost of the works to be performed under the contract.</p>
