General Manager (IT), on behalf of Maharashtra State Electricity Distribution Company Limited (the Employer), hereby invites sealed bids from eligible bidders for '**Supply, Installation and Commissioning of Modems**'. Entire bidding document is available on MSEDCL e-Tendering Website <http://works.mahadiscom.in/eTender/etender> as per date indicated below. Any changes in the Bid Schedule, corrigendum etc. shall also be notified via MSEDCL's website. Prospective bidders are therefore requested to regularly check the website for any updates.

**Tender Fee: Rs. 5,000/-** Plus 18% GST

The bidder should submit non-refundable Bid Fee of Rs. 5,900/- in the form of online payment on e-Tendering Website.

**Bid Security:** The bid must be accompanied with Bid Security for an amount equal to Indian Rs. 1,37,300 (Rs. One Lakh Thirty Seven Thousand Three Hundred only) for covering the entire scope of work. The bid security shall be denominated in Indian Rupees only. The bid security shall be paid on-line or submitted in the form of Demand Draft from any Nationalized/ Scheduled Bank in favour of the **Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai** as mentioned in details in Tender Document (RFP). The Demand Drafts should be submitted to this office on or before submission date and time.

- 2) Following qualifying requirements should be met by the agency individually or in case of consortium, the QR should be met by all the consortium members collectively.

**Brief Scope:**

**i. Supply of modems :**

The bidder shall be responsible for supply of modems as per technical specifications given in tender document, at various destination sites of the Purchaser in Maharashtra along with all required hardware accessories for installation and commissioning of modem and connecting modem to AMR end point such as antenna, connectors, RS232 cable for connecting modem to AMR end point, etc.

**ii. Installation and Commissioning of modems :**

The bidder shall be responsible for installation of modems at various AMR end points. He shall be responsible for provision of all required manpower and tools/kits for safe, reliable, proper and correct installation and commissioning of modems at given locations.

**iii. Integration of modems with MSEDCL MDAS :**

The bidder should integrate the modems configured with MSEDCL MDAS. The details of modem, meter and SIM cards should be entered in MSEDCL MDAS.

**iv. Acceptance procedure :**

Installation, commissioning of modem and integration with MSEDCL MDAS will be treated as successful only after availability of complete meter data in MSEDCL MDAS through modem, at least once.
