The bid security shall be denominated in Indian Rupees only. The bid security shall be paid in in form of Unconditional Bank Guarantee (as per prescribed format) payable at Mumbai or DD from a Nationalized/Scheduled Bank in favour of the Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai as mentioned in details in Tender Document.

## Brief Scope:

- i. Selected Bidders shall enter into contract with MSEDCL for providing Bandwidth services for MSEDCL AMR NETWORK for the term of 3 years.
- ii. Selected Bidders will have to supply the required no. of Project SIMs (Public or Private as per requirement) with data and SMS services enabled to MSEDCL Corporate Office, as and when required during the term of contract.
- iii. Selected Bidders will have to make provision for sufficient Backhaul leased lines/secure tunnels through internet at MSEDCL Data Center (Mumbai), MSEDCL Cloud (AWS) and Disaster Recovery Site (Nagpur). The configuration and integration of the Backhaul leased lines/secure tunnels through internet with the Data Centre, AWS Cloud, Disaster Recovery Centre will be in the scope of the bidder.
- iv. Approx. 185000 AMR endpoints are estimated to be covered during contract period. Letter of Awards will be placed to empanelled bidders as per requirement of SIMs received.
- v. In addition to meeting Service Level Agreement (SLA) terms of this RFP (Section 8 (G)), Selected Bidder(s) shall ensure 98 % BTS Uptime. Up time would be calculated on a monthly basis (as per TRAI report of BTS uptime or as agreed in Contract agreement) in accordance with the relevant SLA requirements of the Contract. BTS uptime report to be provided by NBSP to MSEDCL
