Section 1 Clause 5.7 "Litigation History"

Please read as under Section-I, 5.7 Litigation History:

- 1. The bidder (in case of JV) partners have to submit the details of all on-going Litigations either in the court of law and/or arbitral panel.
- 2. The aggregate amount of pending litigations shall not exceed 50% of Bidder's net worth.
- 3. In case amount is more than 50%, bidders shall be disqualified.

<u>Definition for pending litigations: This includes litigations filed against the bidder and litigations filed by the bidder.</u>

Section 1, Clause 16.7, "Recovery of mobilization advance" (BE READ AS UNDER)

- i) The mobilization advance shall be recoverable/ adjustable in maximum six equal instalments, starting from adjustment against first R.A Bill.
- ii) If in case contractor do not raise R.A. bill up to sixth month from issue of LoA, their mobilization advance shall be recovered by encashing B.G submitted against advance and performance bank guarantee together with interest @12% per annum.
- iii) If in case advance could not be recovered fully up to nine months from the date of LoA then balance portion of advance shall be adjusted by encashing B.G given against mobilization advance.
- iv) Agency will have the liberty to repay the advance or get the amount deducted in less no. of bills.
- v) Reduction of BG is not permitted till 100% recovery of mobilization advance.
- vi) BG against mobilization advance will be returned after 100% recovery of mobilization advance.
