Sirs,

- 1) As per your application for vendor Registration as supplier of 11 KV ,22 KV RMU was processed and approved by MSEDCL on the basis of certain documents like-type test Reports, Drawings, GTP etc. submitted by you.
- 2) On verification of type test reports from CPRI Bhopal testing laboratory (From whom the same have been pretended to be issued), CPRI Bhopal has communicated that the same have not been issued by them and found to be fake.
- 3) Since, the alleged malpractice of playing fraud on MSEDCL by submitting such fake or forged documents by your concern has attracted the ground for debarring your company from the business dealings with MSEDCL as contemplated under clause 9 of 'MSEDCL's Debarring Policy'.

- 4) Further, the show cause notice was issued by this office vide Letter No. CE/Testing & QC/MSC/HTS/19326 dt.09.07.2019 stating "why the action of debarring your company from business dealings with MSEDCL shall not be taken against your firm." and to the same you have replied vide your letter under ref .No (5), that you have committed violation of the conditions of MSEDCL for vendor approval and tendered apology.
- 5) Now this office decided "To cancel the vendor approval awarded vide letter under ref 1 & 2 for supply of 11KV and 22 KV RMU's with immediate effect and to debar your firm from dealing business for period of Three Years i.e 26.08.2019 to 25-08-2022. The material supply/purchase process if initiated in respect of MSEDCL is hereby terminated with immediate effect. M.S.E.D.C.L. is not bound to bear any financial losses accounted on your side due to debarring.
