Dear Sir,

Considering the non-supply of materials ,the subject order placed on your firm for order quantity of 510 Nos. of LT Distribution Boxes of ratings 100KVA manufactured by using Fabrication process with KITKAT, 210 Nos. LT Distribution Boxes of ratings 63KVA manufactured by using Fabrication process with MCCB and 490 Nos. LT Distribution Boxes of ratings 63KVA manufactured by using Fabrication process with KITKAT was cancelled with recovery of damages of 10 % value of non-supplied material amounting to Rs. 20,57,828 /- plus applicable taxes vide T.O. letter dtd. 28-01-2020 under reference (1).

Further this office also requested you to remit Rs. 20,57,828 /- (Rupees Twenty Lakhs Fifty Seven Thousand Eight Hundred Twenty Eight Only) plus applicable taxes towards the cost of damages to General Manager (C.F.), MSEDCL, Prakashgad, Bandra (East), Mumbai-400 051 within 14 days from the letter dtd. 28-01-2020, failing which M.S.E.D.C.L. shall be constrained to take suitable action for recovery of damages such as forfeiting of the Security Deposit against the subject order and recovery from pending bills with MSEDCL.

Further as per clause no. 33, Termination of contract/debar/blacklist of Section-II of A/T and MSEDCL debar policy dtd. 11-06-2018 you were also requested to submit your justification that why your firm should not be debarred from business dealing with MSEDCL upto a period of three years and also as per clause no. 35 of Section-II of A/T why the name of your firm should not be removed from the list of registered vendors of MSEDCL's e tendering system upto a period of three years.

However, the same is not found satisfactory and hence as per clause no. 33, Termination of contract/debar/blacklist of Section-II of A/T and MSEDCL debar policy dtd. 11-06-2018, your firm is hereby debarred from business dealing with MSEDCL upto a period of three years from the date of this letter. Also as per clause no. 35 of Section-II of A/T, the name of your firm is removed from the list of registered vendors of MSEDCL's e-tendering system upto a period of three years from the date of this letter. Further, the Security Deposit of Rs. 10,000 /- paid vide Money receipt No. 792464 dtd. 21-01-2019 against the subject order is hereby forfeited.

This is issued without prejudice to other terms and condition of the subject purchase order.
