Chief General Manager (IT), on behalf of Maharashtra State Electricity Distribution Company Limited (the Employer), hereby invites sealed bids from eligible bidders for 'Appointment Cum Empanelment Of Network Bandwidth Service Providers For MSEDCL AMR Activities'. Entire bidding document is available on MSEDCL e-Tendering Website <https://etender.mahadiscom.in/eatApp/> as per date indicated below. Any changes in the Bid Schedule, corrigendum etc. shall also be notified via MSEDCL's website. Prospective bidders are therefore requested to regularly check the website for any updates.

Tender Fee: Rs. 25,000/- Plus 18% GST

The bidder should submit non-refundable Bid Fee of Rs. 29,500 /- in the form of online payment on e-Tendering Website.

Bid Security: The bid must be accompanied with Bid Security for an amount equal to Indian Rs. 40,36,547 (Rs. Forty Lakhs Thirty Six Thousands Five Hundreds Forty Seven only) for covering the entire scope of work. The bid security shall be denominated in Indian Rupees only. The bid security shall be paid on-line or submitted in the form of Bank guarantee from any Nationalized/ Scheduled Bank in favour of the **Maharashtra State Electricity Distribution Co. Ltd., payable at Mumbai** as mentioned in details in Tender Document (RFP). The Bank guarantee should be submitted to this office on or before submission date and time.

Brief Project Scope:

- Selected Bidders shall enter into contract with MSEDCL for providing Bandwidth services for MSEDCL AMR NETWORK for the term of 3 years.
- Selected Bidders will have to supply the required no. of Project SIMs (Public or Private as per requirement) with data and SMS services enabled to MSEDCL Corporate Office, as and when required during the term of contract.
- Selected Bidders will have to make provision for sufficient Backhaul leased lines/secure tunnels through internet at MSEDCL Data Center (Mumbai) and MSEDCL Cloud (AWS). The configuration and integration of the Backhaul leased lines/secure tunnels through internet with the Data Centre and AWS Cloud will be in the scope of the bidder.
- Approx. 600000 AMR endpoints are estimated to be covered during contract period in phase wise manner.

Qualifying Requirements:

1. The bidder should be a Company Registered under Company act 1956.
2. The bidder should be a National Long Distance Service Provider or IP VPN service provider/Basic Service Operator/Unified Access Services licensee having own MPLS VPN network under license from Department of Telecommunications (DoT), Govt. of India.
3. The bidder should have been in operation for a period of at least 3 years in Telecom field in India.
4. The bidder should have minimum average annual turnover of at least Rs. 100 Crores for the last three audited financial years. (i.e. FY19-20, FY20-21 & FY21-22). In case audited statements of FY21-22 are not available, then turnover of FY18-19, FY19-20 & FY20-21 will be considered.

5. The Bidder should have a positive net worth during any of the last three audited financial years (i.e. FY19-20, FY20-21, FY21-22). If the audited statements for FY 21-22 are not available, then the financial statements of (FY18-19, FY19-20, FY20-21) will be considered.
6. The bidder should have valid certification for ISO 9001:2015.
