Ltd., payable at Mumbai as mentioned in details in Tender Document (RFP). The Bank Guarantee EMD (original copy) should be submitted to this office on or before Bid end date.

Brief scope of work

Supply, installation and commissioning of 342 nos. 250 GB SSD (M.2 NVME) for laptops of Corporate office employees as per delivery location mentioned in Annexure-C of tender.

Qualifying Requirements:

1. The bidder should be a Company registered in India under the Companies Act 1956/ 2013 or a partnership registered under the Indian Partnership Act 1932 with their registered office in India or a proprietor licensed in India. The Bidder should have been in operation in India for minimum of three years.
2. The bidder must have minimum average annual turnover of Rs. 14 Lakhs for last 3 audited financial years.
3. The Bidder should have a positive net worth and should be in profit in each of the last three audited financial years.
4. The Bidder should have experience of supply and installation of computer peripherals/IT infrastructure hardware in the last 7 Years upto date of tender publishing as under,
 1. One similar work order/Contract costing not less than Rs. 11.29 Lakhs
 - OR
 2. Two similar Work Orders/Contracts costing not less than Rs.7.06 lakhs each

OR

3. Three similar Work Orders/Contracts costing not less than Rs. 5.64 lakhs each

5. The bidder must be registered for GST.
6. The Bidder should not have been blacklisted by any Private/PSU/Central Govt./State Govt. or any other Organization or agencies in India at the time of submission of the bid. Note: MSEDCL debarring policy will be applicable to the bidder.
