In response to the offer submitted by your firm against tender no.Billing/EE/BSR/T-23/09-2019 the work order for taking Monthly Meter Reading of LT consumers up to 20kW (Excluding AG consumers other than Ag metered UrbanLT consumers coming under Municipal Corporation , Municipal Council , Nagar Parishad and Nagar Panchayat.)under Bhosari I sub division to be done using Mahavitaran Mobile App,IR/RF HHUs,Bill Printing and Bill distribution upto consumer /consumer premises of Bhosari Division was issued to you.

Vide letter under ref. (4) to (7), the Bhosari Division office has taken rigorous correspondence to you regarding lethargic approach towards above mentioned work. Major abnormalities found were:

- Normal Billing percent of M/S Sunrise Enterprise is less than 90% for Mar. 21 to Sept. 21
- Taking less meter reading than present on meter.
- Taking blur photo of meter purposefully and feeding less meter reading.
- Deliberately issuing bills under faulty status in spite of being healthy meter with less meter reading.
- The cases found in Feb. 2022 - 124 nos.
Accumulated units in above cases – 549067 units
Revenue blocked against above cases -7368855 Rs.
- The bills were not distributed after due date.
- Piling of bills at one place.
- Reading of Common meter of Society, construction meter has not been taken regularly which has been resulted in accumulation of reading.
- Reading of slum area like Landewadi, Balaji nagar, Mahatma Phule Nagar, Indrayani Nagar not taken since 6 to 7 months.


Due to seriousness of matter, enquiry committee was formed by Pune Zone office. As per findings of committee and terms and conditions of tender and contract Section IV, Clause 15,

15. DEBAR POLICY AND PROCEDURE OF MSEDCL:

If Agency either repeatedly fails to complete the allotted work as per schedule or fails to rectify major defects notified and to maintain quality of work or continues repeating the same defects and further again in any subsequent orders/work contracts issued,either partly or completely or found to have committed deception, fraud or misconduct or any other act which is not in the interest of MSEDCL thereby violating the provisions of tender/contract conditions;theninsucheventtheMSEDCLreserveseveryrightto take penal actionswhichmay,interalia,include terminationof the contractand/or debarringthetendererfromparticipatinginfuturetender/tendersfor maximum up to5years and in exceptional cases the cumulative period for debarring may be extended up to 10 years and area of debarment is for entire MSEDCL alongwithany penal actionasdeemedfitforrecoveryforliabilitiesasstatedin the tender document. In case of failure on part of successful bidder at any stage of tendering and execution, the bidder/ contractor may be debarred as per MSEDCL debar policy provided on MSEDCL website link. (Refer Policy and Procedure for debarring of Agencies from business dealings with MSEDCL as per Circular vide ED(Infra)/Tech/Debar policy/no. 14238 dated 11.06.2018)

Hence as per approval received from zone office vide ref. no. (8), the under signed has decided to

blacklist/Debar your agency M/S Sunrise Enterprises for business dealing with MSEDCL for 5 year from the date of issue of this letter.
