Qualification Requirements:

- The bidder should be a single company registered / incorporated in India under companies act 1956 and 2013 or LLP with registered office in India and should have been in operation in India. The Bidder should have been in operation for a period of at least 3 years in Telecom industry.
- Bidder should be a National Long-Distance Service Provider or IP VPN service provider having own
 Point to Point and Internet Leased line network under license from Govt. of India. This License
 should be valid during the contract period.
- 3. The Bidder shall have a valid PAN and GSTIN Number.
- 4. Bidder should have cumulative turnover of at least Rs. 12.5 Crore for the last three audited financial years.
- 5. Bidder should have Supplied, Installed, Integrated, Tested and Commissioned MPLS or Internet or Point to Point Leased Lines in any sector, during preceding seven years (till the date of bid submission) fulfilling any one of the following criteria:
 - ➤ One similar work order/contract equivalent to at least Rs.2 Crores.
 - ➤ Two similar work orders/contracts costing not less than Rs.1.25 Crores each.
 - ➤ Three similar work orders/contracts costing not less than Rs.1 Crores each.
- The Bidder should have relevant ISO 9001:2015 or TL 9000, ISO 27001:2013 or latest & ISO 22301:2019.
