It is the grievance of the complainant no \_\_\_\_\_ is that the complainant electricity bearing consumer No.490012456121 has been taken for his floor mill and sanctioned in the year September 2009, the respondent MSEDCL \_\_\_\_\_ on 6<sup>th</sup> March 2009 and issued the exorbitant bill of Rs.25,520/-

On 30<sup>th</sup> October 2010, the respondent taken action, the electricity meter without any notice and then issued another bill of Rs.43,417/-.
