**INTERIM ORDER**

The consumer has filed an application for passing interim order for reconnection of his electricity supply which has been disconnected by the Distribution licensee without any prior notice and for arrears shown in the bill due to wrong meter reading taken by the Distribution licensee.

On hearing both the parties, prima-facie, we observed that , the bill issued by the D.L. for the month Sept.2007 shows wrong meter reading which has resulted in showing arrears in the next months bills on account of which the supply has been disconnected by the D.L. without giving prior intimation to the consumer.

Therefore in the interest of justice and as per provision No.6.5, of the Regulation 2006, the Forum hereby direct the D.L. to reconnect the electricity supply by 17.00 hrs of 08.01.2008.
