INTERIM ORDER

The consumer has filed an application in the Forum against the decision passed by the Internal Grievance Redressal Committee , Urban Circle, Aurangabad . He has also filed separate application stating that the Distribution Licensee may disconnect the electricity supply of his factory for the disputed bill He therefore requested the Forum to direct the Distribution Licensee not to disconnect his supply till the disposal of grievance is redressed .

The hearing on the matter of passing interim order was kept on today 8th April 2008. The consumer Shri Arun Patni and Nodal officer Shri S.G.Pawar was present. Both the parties were heard. The Nodal officer stated that he has no objection to grant the request of the consumer as the matter is already filed by the consumer in the Forum.

It is observed that the Distribution Licensee has issued the bill under dispute by levying the maximum demand charges based on previously recorded demand which prima-facie seems to be incorrect . Therefore in the interest of justice and as per provision No.6.5 of the Regulation , the Forum hereby direct the Distribution Licensee not to disconnect the electricity supply of the consumer.

This Interim order shall be subject to final decision on the grievance of the consumer, that may be passed by the Forum. The next date of hearing is kept **on 15.4.08 at 12.45 hrs.**
