**JUDGEMENT**

The complainant has submitted his complaint against the bills.

It has been submitted that, his electricity connection has been cut off permanently. His electricity meter was also taken away by the officers of MSEDCL but the officers of MSEDCL are issuing the bills in order to harass the complainant. It is therefore prayed that the bills issued by respondents be cancelled.

The Nodal Officer has submitted reply to the complaint and pleaded that, the bills during the period April 2009 to March 2010 have been issued at average consumption of 100 units. The respondents MSEDCL has deducted the sum of Rs.4182.95 paise.

The GTL has submitted reply to the complaint and pleaded that, the complainant is using meter of Bhimrao Kadam. Spot Inspection has been made by GTL. As per spot inspection, there was no meter on the site, but the complainant is using unauthorized electricity supply from neighbouring meter. The complainant is using illegal connection. He has not paid electricity bills since September 2010. The complaint should be therefore dismissed.

This Forum heard submissions of complainant. The Nodal Officer argued for MSEDCL Mr. Borde Legal Manager argued for GTL.

We perused verification report of consumer. As per such verification report, the complainant is using electricity from neighbouring meter of Mr. Mahale. The said report is not disputed by the complainant. It therefore reveals that, the complainant is using and consuming electricity unauthorisedly. The MSEDCL has already deducted the sum of Rs.4181.95 paise. It therefore reveals that, there is no merit in the complaint. Moreover the complainant is not the lawful consumer of respondents. The complainant should be therefore dismissed. Hence this Forum proceed to pass following order.

**ORDER**

01. The complaint is hereby dismissed.
