INTERIM ORDER

- This Representation is filed on 01st April 2016 by above named 1. consumer having connection under the category 04 LT II commercial 1phase connected Load 2KW, sanction load -2KW date of connection 27.09.2013.
- It is the case of the Appellant / Consumer that they are running Yadav Juice Centre opposite Meghraj Theatre Sector- 2, Vashi.
- The above said consumer not demanded NOC at the time of date of connection dated 27.09.2013. This consumer regularly depositing Electricity bill and the receipt are filed along with complaint. We have obtained details status of the payment schedule from online. It appears that the connection seems disconnected without any legal notice and record shows the connection is PD. However consumer deposited current bill Rs. 3260/- receipt

is filed due to which consumer suffering heavy loss of business is selling the juice on his centre. Considering, it is pick summer season for the benefit of public and only earning source available to consumer should not be suffer. Therefore this complaint is considered as emergency relief necessary to the pass order in favour of consumer at interim stage.

- 4. I have perusal all the document and earlier dispute letter issued by CE/Commercial/16647/dtd. 12.06.2013 reviewed no NOC is required. At the time of granting service connection unless objection raised by Competent Authority. There is no record about filing of any complaint by Competent Authority. Therefore I am inclined to consider dispute and pass interim order as follows.
- 5. The Addl. Executive Engineer, Sector-2 Vashi of the Respondent is directed to restore the supply of the consumer, Yadav Juice Centre in favour of Shri. Shambhu Zinku Yadav forthwith within two hours from the receipt of this order without asking for reconnection charges. The Respondent is further directed not to disconnect the supply till the grievance is finally decided by the Forum. This order be communicated to the concerned office of the MSEDCL on mail and or by fax.

The Forum is likely to hear the matter on 06th April 2016 and pass the appropriate order as early as possible. Representation is accordingly disposed of.

6. The Compliance to be reported along with reply by the Respondent within on due dates from the date of this order.
