Maharashtra Electricity Regulatory Commission, is, constituted u/s. 82 of Electricity Act 2003 (36/2003). Hereinafter for the sake of brevity referred as 'MERC'. This Consumer Grievance Redressal Forum has been established as per the notification issued by MERC i.e. "Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Ombudsman) Regulation 2006" to redress the grievances of consumers vide powers conferred on it by Section 181 read with sub-section 5 to 7 of section 42 of the Electricity Act, (36/2003).

## GRIEVANCE NO. K/E/1006/1217 of 2015-16 ID 2016030125

Hereinafter it is referred as 'Regulation'. Further the regulation has been made by MERC i.e. 'Maharashtra Electricity Regulatory Commission. Hereinafter referred as 'Supply Code' for the sake of brevity. Even, regulation has been made by MERC i.e. 'Maharashtra Electricity Regulatory Commission (Standards of Performance of Distribution Licensees, Period for Giving Supply and Determination of Compensation) Regulations, 2014.' Hereinafter referred 'SOP' for the sake of convenience (Electricity Supply Code and other conditions of supply) Regulations 2014'.

- 2] Short issue involved in this case is whether the Licensee -MSEDCL has charged and recovered FAC strictly as per the post facto approval of Commission.
- In particular the consumer herein bearing No. 020029007714 MSEDCL Kalyan Circle-I alleges that FAC was charged by MSEDCL, for the period of December 2013, February 2014 and May 2014 not according to the Commercial orders of MERC. Consumer has referred to---
  - 1] MSEDCL Circular No .189,193, regarding charging of FAC.
  - 2] MERC Order dtd. 04/09/2013 in case No. 44/2013.
  - 3] MERC Order did. 26/7/2015 in case No. 95/2013 & M.A.No.187 of 2014.

It is prayed that the said bills for the said period be revised accordingly.

- 4] We have heard both sides.
- Considering the argument on either side. We are of the opinion that the grievance can be disposed of by giving directions to the Licensee MSEDCL to recalculate the FAC strictly as per approval of the Commission and within a fixed time limit.

## **ORDER**

- 1] MSEDCL is directed to verify the claim of the consumer as per post facto approval given by the Commission and refund / adjust the amount, if any due. This exercise be completed by the Licensee MSEDCL within one month from the date of receipt of this order.
- 2] Compliance be reported within a period of two months from the date of receipt of this order.
