IN THE MATTER OF GRIEVANCE NO. K/N/758/914 OF 2013-14 IN RESPECT OF AMOUGH CHEMICAL PVT. LTD. N-79,MIDC,BADLAPUR DIST-THANE, REGISTERED WITH CONSUMER GRIEVANCE REDRESSAL FORUM KALYAN ZONE, KALYAN REGARDING REFUND OF RLC CHARGES AS PER MERC ORDER.

1] Maharashtra Electricity Regulatory Commission, is, constituted u/s. 82 of Electricity Act 2003.(36/2003). Hereinafter for the sake of brevity referred as 'MERC'. This Consumer Grievance Redressal Forum has been established as per the notification issued by MERC i.e. "Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Ombudsman) Regulation 2006" to redress the grievances of consumers vide powers conferred on it by Section 181 read with sub-section 5 to 7 of section 42 of the Electricity Act, (36/2003).

2] Consumer approached this Forum with grievance on 29/1/2014, as Licencee failed to refund the RLC amount. All the papers along with grievance were sent to

Nodal Officer along with letter of this Forum bearing No. EE/CGRF/040/dated 29/1/2014. On behalf of Licencee, Nodal Officer and concerned Dy.Exe. Engineer attended.

3] This grievance is filed by the consumer on 29/01/2014, regarding refund of RLC charges as per MERC order. On behalf of Licencee, letter dated 24/2/2014 addressed by Dy.Executive Engineer to Executive Engineer MSEDCL is placed on record, requesting for refund of RLC to the tune of Rs.1,51,865.41 to the consumer .

4] In this matter, we noted that this Forum decided present consumer's grievance, pertaining to refund of this RLC in Grievance No. K/E/0148/169 vide order dated 29/1/2009. Present application is nothing but seeking the relief, aggrieved by non compliance of the order. Accordingly, we find if, consumer is aggrieved by non compliance of order, there is specific Forum available to seek relief and it is with Hon'ble MERC. In spite of it consumer has opted to seek execution of our own order and we find such execution is to be sought before Hon'ble MERC. Hence grievance is to be disposed off.

Hence the order.

ORDER

Grievance stands disposed off as prayer towards execution of orders of this Forum not tenable before this Forum, which is to be taken to Hon'ble MERC.
