Maharashtra Electricity Regulatory Commission, is, constituted u/s. 82 of Electricity Act 2003 (36/2003). Hereinafter for the sake of brevity referred as 'MERC'. This Consumer Grievance Redressal Forum has been established as per the notification issued by MERC i.e. "Maharashtra Electricity Regulatory Commission (Consumer Grievance

Redressal Forum & Ombudsman) Regulation 2006" to redress the grievances of consumers vide powers conferred on it by Section 181 read with sub-section 5 to 7 of section 42 of the Electricity Act, (36/2003). Hereinafter it is referred as 'Regulation'. Further the regulation has been made by MERC i.e. 'Maharashtra Electricity Regulatory Commission. Hereinafter referred as 'Supply Code' for the sake of brevity. Even, regulation has been made by MERC i.e. 'Maharashtra Electricity Regulatory Commission (Standards of Performance of Distribution Licensees, Period for Giving Supply & Determination of Compensation) Regulations, 2014.' Hereinafter referred 'SOP' for the sake of convenience (Electricity Supply Code and other conditions of supply) Regulations 2014'.

2] Consumer is having supply bearing consumer No. 001840494434 and demanded the refund of IC+GC+TC & PF charges wrongly collected by Licensee for 05 month instead of one month, collective consumption for consumer No. 001840494434- LTVB - PD in March 2015 and merged in consumer No. 001840496429. The MSEDCL Comm. Cir. No.236, has verifies that till December 2014 the Govt. of Maharashtra has subscribed the charges of consumers for Residential, Industrial and Agriculture and it should be refunded to the consumers in next month. Therefore, the consumer approached this Forum on 27/10/2015. His grievance application along with accompaniments sent to the Nodal Officer vide this Office letter No.EE/CGRF/Kalyan/315 dated 30/10/2015.

Today i.e. on 08/07/2016 CR Shri Harshad Sheth and Officers of Licensee are present. In this case, there was a grievance of consumer regarding refund of IC+GC+TC & PF charges wrongly collected by

Licensee for 05 months instead of one month collected in the month of January 2015 and made PD in February. However, the Licensee has rectified it and has given (paid) the total amount of Rs. 82,780/- against PF penalty and IC/GC/TC charges. The consumer further submitted that by considering the refund of IC/GC/TC charges inMarch 2015 for Rs.73,070/ and unpaid bill of February 2015 for Rs. 61,770/- adjusted against the said refund. The CR has given in writing that Licensee has settled consumer's claim in full and final satisfaction and pleaded that Licensee given the amount of Rs. 82,780/- towards IC/GC/TC charges and now there is no grievance for refund of IC/GC/TC charges. The CR also stated that they do not demand any extra interest and compensation as per SOP 2014.

This matter could not be decided within time as CR has submitted that he is suffering from knee pain and requested to adjourn his grievance applications till June 2016. The then the Executive Engineer has heard the grievance from both sides. In the meantime, the then the Executive Engineer-cum-Member Secretary has been transferred. Moreover, this Forum is functioning in absence of regular Chairperson and regular Member Secretary, the present Member Secretary in charge is discharging the additional work of Chairperson along with the regular work of Member Secretary from 28/6/2016, in addition to his regular portfolio as Executive Engineer Enquiry MSEDCL for Kalyan Region.

Hence the order.

## **ORDER**

Grievance of consumer is hereby disposed off.
