IN THE MATTER OF THE GRIEVANCE NO. K/E/824/1000 OF 2014-15 of 2014-15 IN RESPECT OF SHRI VIJAY D. MANGTANI, SHOP NO. 4, SHAHANSHAH TOWER, NEAR SAPNA GARDEN, ULHASNAGAR -421 003, DIST. THANE, THANE REGISTERED WITH CONSUMER GRIEVANCE REDRESSAL FORUM KALYAN ZONE, KALYAN REGARDING REFUND OF SECURITY DEPOSIT.

Thane (Consumer No. 021514006251) (Hereinafter referred as Consumer) Versus Maharashtra State Electricity Distribution Company Limited through its Nodal Officer, Kalyan Circle-II,MSEDCL Ulhasnagar- Sub-Divn-III, (Hereinafter referred as Licencee)

Maharashtra Electricity Regulatory Commission, is, constituted u/s. 82 of Electricity Act 2003 (36/2003). Hereinafter for the sake of brevity referred as 'MERC'. This Consumer Grievance Redressal Forum has been established as per the

notification issued by MERC i.e. "Maharashtra Electricity Regulatory Commission (Consumer Grievance Redressal Forum & Ombudsman) Regulation 2006" to redress the grievances of consumers vide powers conferred on it by Section 181 read with sub-section 5 to 7 of section 42 of the Electricity Act, (36/2003). Hereinafter it is referred as 'Regulation'. Further the regulation has been made by MERC i.e. 'Maharashtra Electricity Regulatory Commission. Hereinafter referred as 'Supply Code' for the sake of brevity. Even, regulation has been made by MERC i.e. 'Maharashtra Electricity Regulatory Commission (Standards of Performance of Distribution Licensees, Period for Giving Supply & Determination of Compensation) Regulations, 2014.' Hereinafter referred 'SOP' for the sake of convenience (Electricity Supply Code and other conditions of supply) Regulations 2014'.

2] This grievance is brought before us by the consumer on 6/9/2014 seeking refund of security deposit towards consumer No. 021514006251 standing in the name of Vijay Trading Corporation of Shri Daulatram S.Mangtani. Though in the application there is reference to four consumer numbers, this matter is limited to above consumer number others are also being dealt independently. In this regard, it is seen that for all the four connections consumer with his wife namely Shila approached authorities of Licencee and IGRC on 09/5/2014. IGRC passed order on 20/9/2014 i.e. after consumer approaching this Forum on 6/9/2014.

3] On receiving the grievance, it's copy along with accompaniments, was sent to the Nodal Officer vide this Office Letter No.EE/CGRF/0344 dated 9/9/2014.

In response to it, Officers of Licencee appeared. As noted above order of IGRC is received subsequently and Officers of Licencee submitted reply on 29/9/2014 therein agreed to comply order of IGRC and communicate that Licencee is ready to refund the amount to the consumer by issuing cheque.

4] CR Mr.Rajput, Officers of Licencee attended for hearing and it is clarified that cheque will be issued to the consumer towards refund of security deposit within 15 days. CR submitted that almost all required papers are provided to the

Officers of Licencee. Officers present, admitted such documents filed. Accordingly it is clear that this claim is admitted and payment is being done. Hence needs no any further direction except directing the Licencee to comply the order of IGRC by issuing cheque before end of this month i.e. 30/11/2014 and to report compliance before 20/12/2014.

Hence the order.

ORDER

Grievance application stands allowed, as Licencee agreed to issue cheque in the name of above named applicant/consumer in compliance with the order of IGRC which is to be complied by Licencee prior to 30/11/2014 and it's compliance be reported before 20/12/2014.
