ORDER

(Passed this 5th day of March,2009)
(Per Shri V.R. Khobragade, CHAIRMAN)

1. Being no communication from IGRC, Wardha in response to the application made on 17/10/2008, one Shri Nagorao Dewase filed the application before Forum on 12/2/2009. Shri Dewase who is duly nominated representative of the Applicant of Smt. Kantabai T. Hazare requested to grant necessary compensation as per provisions in force.
2. After receipt of his application, the Forum issued acknowledgement to Applicant, called parawise comments of the non-applicants(hereinafter called 'DL'/'NA'), a copy of the parawise comments was sent to the Applicant, issued notices to both the parties, finally heard both the parties on 26/2/2009. Forum thus, offered a fair, reasonable and adequate opportunity to both the parties for submission of their say in the matter.
3. On the date of hearing, neither Applicant nor her duly nominated representative remained present, whereas the non-applicants were represented through A.E.,Karanja.

One Shri Tejraoji Hazare appeared and filed an application signed by original consumer Smt. Kantabai Hazare stating therein that Shri Tejraoji has duly been nominated to represent the case on her behalf- There is since no provision in rule-Regulation to nominate second representative, the request made vide her authority letter dated 26/2/2007 was rejected.

4. On perusal of record, there is no copy of the order passed by IGRC, Wardha In absence of any communication from IGRC, Forum has no option but to reject the application made to Forum on 12/1/2009. Forum further makes it clear that on receipt of copy of order of IGRC Applicant may file fresh application to Forum within stipulated time or she may avail of right to come wthin time prescribed with a rfresh application before Forum.
5. With the above observations, the Forum unanimously pass the following order.

-: ORDER :-

1. The case is rejected.
2. Chairman, IGRC, Wardha is directed to communicate the decision held in the case.
3. Parties to bear their own cost.
4. Parties be informed accordingly.
