1. Since there was no communication from IGRC, Wardha, one Smt Vimalabai L. Hazare made application to Forum through her representative Shri Nagorao Dewase.
2. After receipt of his application, the Forum issued acknowledgement to Applicant, called parawise comments of the non-applicants(hereinafter called 'DL'/'NA'), a copy of the parawise comments was sent to the Applicant, issued notices to both the parties, finally heard both the parties on 16/2/2009. Forum thus, offered a fair, reasonable and adequate opportunity to both the parties for submission of their say in the matter.
3. Shri M.B.Dhabarde,A.E. represented the case for company. He reiterated the same points as mentioned in the parawise comments submitted to the Forum.
4. On the date of hearing, neither Applicant nor her representative remained present.

5. On going through papers it has come to notice of Forum that signature bearing on original application filed to Karanja and signature appearing on application filed before Forum, does not tally. It has further come to notice that the lady does not reside at village Morshi. Neither Applicant lady nor her representative communicated any reason for non-appearance on the date of hearing. Since question of genuineness of signature arises, the Forum decide unanimously to reject the application.
6. With the above observations, the Forum unanimously pass the following order.
