1. Being no communication in response to the application filed to IGRC, Wardha, the Applicant came to Forum on 13/1/2008 requesting to grant compensation as per provision in force.
2. After receipt of his application, the Forum issued acknowledgement to Applicant, called parawise comments of the non-applicants(hereinafter called 'DL'/'NA'), a copy of the parawise comments was sent to the Applicant, issued notices to both the parties, finally heard both the parties on 2/3/2009. Forum thus, offered a fair, reasonable and adequate opportunity to both the parties for submission of their say in the matter.
3. On the date fixed for hearing, Shri V.P.Yaul, E.E., Arvi and Shri M.B.Dhabarde, A.E., Karanja were present on behalf of non-applicants and they reiterated the same

points as mentioned in their parawise comments. Neither the Applicant himself nor his representative appeared in this case. Even Applicant or his representative did not care to communicate about their absence. In the light of Clause No. 6.16 of MERC(CGRF&EO) Regulation,2006, Forum decide to proceed further ex-parte.

4. With the above observations, the Forum unanimously pass the following order.
